- Current WV Paramedic certification, or the ability to obtain within 60 days;

- Completion of an approved Emergency Vehicle Operators Course (EVOC)
- Valid Driver's License
- Firefighter I certification (WV, ProBoard, or other acceptable equivalent)\*
- Firefighter II certification OR Vehicle & Machinery Rescue Operations\*

\*\*Applicants without fire training will be considered, provided they are willing and able to obtain the required training within 1 year of hire.

JCESA is a component agency whose mission is to assist the volunteer fire departments in providing fire and emergency medical services to the residents and guests of Jefferson County. We do this by placing employees in the volunteer stations to respond alongside our volunteer partners. 8, 12, and 24 hour shifts are available for part time paramedics. Full-time paramedics work a 24/72 schedule.
