Jefferson County Homeland Security and Emergency Management uses NIXLE Alerts to send emergency alert notifications by text, e-mail, Facebook and Twitter. We send out weather watches and warnings, as well as Emergency Public Information during disasters. Examples include tornado, flood, severe snowstorm, and severe thunderstorm watches, warnings, advisories, and emergencies, as well as, where emergency shelters are located, where commodities can be obtained, etc. Signing up is easy and its FREE! To sign up, go to

http://local.nixle.com/register or text your zip code to 888777 and then text JCHSEM to the same number.

In addition to NIXLE, we still use traditional media, such as newspapers, TV, and radio, however, receiving NIXLE alerts on your phone is the fastest way to receive emergency public information. Make sure that everyone in your family that has a phone, receives our emergency alerts in case that you are not together when a disaster happens. Make receiving NIXLE Alerts a part of your family's communication plan. If you have questions about NIXLE Alerts, you can go to www.nixle.com and click on "resident". Ten Things you can do to Protect your Property from Flooding

Know Your Risk

Buy Flood Insurance

A regular home insurance policy does NOT include insurance against flooding. You will need to purchase a separate policy. In order to purchase flood insurance, your local municipality or county government has to be a member of the National Flood Insurance Program, which includes the local government agreeing to have and enforce a local floodplain ordinance. Add Increased Cost of Compliance

Get your permits! Remember to talk to your local floodplain manager before starting any work to discuss the local floodplain ordinance and find out about required permits.

Raise your electrical outlets, sockets, electrical boxes, switches, circuit breakers and wiring at least 3 feet above the base flood elevation.

Anchor and raise outdoor equipment

Fuel tanks, air-conditioning units and generators should be anchored and raised above your base flood elevation. Unanchored fuel tanks can break free, and severed supply lines will contaminate surrounding ground. Electrical power units and generators should never sit on the ground. These backup facilities will be inundated (by water) and useless.

Modify water valves

A flooded sewer system can cause sewage to back up into your home. Install an interior or exterior backflow valve. The Federal Alliance for Safe Homes, or FLASH, recommends gate valves. They are more complex, and you operate them by hand. But they provide stronger seals than flap or check valves, which open automatically to allow water to flow out and then close when water tries to get in. Valves should be installed on all pipes entering the house, FLASH advises. 8. Determine how water flows around your house

Called the grading or slope, the angle of the ground can direct water to or away from your house. Obviously, it's best if the home was built so that water drains away from the building.

This is easy enough to determine by watching how water flows or accumulates during an average rainstorm, says FLASH President and CEO Leslie Chapman-Henderson.

If your proprty is prone to standing water even after a fairly ordinary rainstorm, talk to a professional to have the problem corrected.

Opt for a major retrofit

If your home floods frequently and moving isn't an option, you may need to take drastic and costly measures. FLASH's home safety program suggests 3 options:

Raise your home on piers or columns so that the lowest floor is 3 feet above the flood level. Experts tell FLASH that such an undertaking would cost \$20,000 and up.

"Wet-proof" your home by installing foundation vents that would allow water to flow through the building, instead of rising inside and causing more damage. You'd need at least 2 vents on different walls. A 1,000-square-foot house would require 7 square feet of flood vents, according to FLASH.

Do some "dry proofing" by applying coatings and other sealing materials to your walls to keep out floods.

Take last-minute measures as waters rise

Clear gutters, drains and downspouts.

Move furniture, rugs, electronics and other belongings to upper floors, or at least raise them off a ground floor.

Shut off electricity at the breaker panel.

Elevate major appliances onto concrete blocks if they're potentially in harm's way from flooding.

JCHSEM Staff to Participate in National Weather Service-Baltimore/ Washington Area's Annual Hydrology Partnership Group Meeting

Each year, the National Weather Service's Baltimore/Washington Forecasting Office holds a hydrology partnership Group Meeting. Representatives from throughout the Baltimore/Washington's forecast area gather at the Sterling Office to review the past year's hydrology issues and discusses plans for improvement in the

coming year. This year's meeting, which will be held on September 22, will include: Year in Review, Ellicott City, MD Flash Flood, Performance Stats / Philosophy Change, DC/Potomac Flood Inundation Maps Demonstration, Plans for 2017, Discussion: Furthering the Flood Partnership, Agency Updates/Open Discussion, and a tour of the NWS office. The Hydrology Partnership Group is made up of federal partners at the United States Geological Survey (USGS), the National Park Service (NPS), and the U.S. Army Corps of Engineers (USACE); our state/district partners at the Maryland Department of the Environment (MDE), the District Department of Energy and the Environment (DOEE), and Virginia Department of Emergency Management (VDEM); and local partners, including local officials



from Jefferson County, WV, the City of Alexandria and Fairfax County.

From Risk to Resiliency: Engaging the Public Flood Focus Group to meet in Jefferson County on October 19th

Jason Elliott, hydrological meteorologist at the National Weather Service in Sterling, in conjunction with Rachel Hogan and the Nurture Nature Center, will host a Flood Focus Group about the Shenandoah River on October 19th in Jefferson County, WV. The guest list is being developed by the National Weather Service and the Nurture Nature Center (NNC).

The NNC recently did a similar study on the Delaware River Basin. Focus On Floods is a flood education campaign developed by the NNC through a cooperative partnership with National Oceanic and Atmospheric Administration (NOAA) and the National Weather Service. Focus on Floods is designed to help residents and individuals in the Delaware River Basin and beyond improve their flood readiness. The project shares information with individuals, via radio, television, Internet and other venues, about how to use National Weather Service flood forecasting and warning tools, and other critical flood preparedness information.

As part of the campaign, NNC developed a variety of outreach materials for adults and children (see images below), a Focus on Floods DVD-Rom, and a new six-chapter media piece called "Understanding Flood Risk in the Delaware Basin" which features a series of interviews with flood authorities and experts who discuss the factors that affect flood risk, and the decision-making processes and new technology that can help reduce losses. West Virginia Homeland Security Region 3 Annual Full Scale Exercise—Dark Grid

West Virginia Homeland Security Region 3, which is comprised of the counties of Jefferson, Berkeley, Morgan, Grant, Hardy, Hampshire, and Mineral Counties, held their annual Full Scale Exercise on Saturday, September 17 throughout the seven-county region.

This year's exercise series, included the April 19 TTX (Tabletop Exercise), a Functional Exercise on June 21 in Hampshire County, and culminates with a Full Scale Exercise on September 17 that will have several field venues throughout the seven counties. It is being designed and directed by representatives of the United States Environmental Protection Agency (EPA) and their contractors. This will be an HSEEP (Homeland Security Exercise and Evaluation Program)compliant exercise. The final injects and specific scenarios of the exercise series are not be announced until each exercise begins.

Participants must be pre-registered with their respective County Emergency Manager and the Environmental Protection Agency and its consultants to participate.

While Jefferson County's participation is strongly geared towards Public Health and Hospital Incident Command, and testing of the flood warning plan, this year, participants are being invited from: Emergency Management (Full EOC Group); Emergency Communications/9-1-1, Fire Service, Haz-Mat, LEPC Members, EMS, Law Enforcement, Mapping/GIS/IT, Board of Education, Shepherd University, Military Assets, National Weather Service, Mass Care (Red Cross, Salvation Army, WVDHHR, WV211, VOAD, Council on Aging, Churches and other faith-based agencies, others), Animal Control, Public Health, Jefferson Medical Center, Clinics, Behavioral Health, Environmental Health, Transportation (DOH, Eastern Panhandle Transit Authority), Amateur radio, Engineering and Public Works, Volunteer Agencies, Utility Representatives, Federal, State and Local elected officials.

The success of the exercise series is determined by feedback from participants and the controllers/evaluators. This exercise series will follow the rules of the Homeland Security Exercise and Evaluation Program (HSEEP).

Mobilizing Faith-Based Community Organizations in Preparedness of Disasters

Date: November 3, 2016 Time: 8am to 5pm Location: Believer's Victory Center - 160 Victory Lane, Moorefield, WV

Course Description:

This 8-hour, planning and management-level course trains faith-based community organization (FBCO) representatives, management-level emergency managers, and first responders from small and rural communities to strategically mobilize and engage members of FBCOs, including religious charities, nonprofits such as the Salvation Army, the American Red Cross, churches (both affiliated and unaffiliated), temples, synagogues, mosques, and NGOs etc., in a reciprocal approach to disaster planning that is integrated into current local and statewide emergency management efforts. This course emphasizes grassroots mobilization and coordination

efforts as a means of engaging all faith communities, thereby reaching those marginalized communities most vulnerable to disaster, most frequently excluded from the planning process, and ultimately, most difficult to aid in recovery. This course introduces vital emergency management concepts to FBCO leaders, many of whom will have had no prior experience with emergency management and also seek to educate emergency managers and first responders about the critical role FBCOs can play in strengthening preparedness.
