# Governor-elect Justice Names Jeff Sandy DMAPS Secretary

Sandy will bring years of experience to WV Department of Military Affairs and Public Safety



Governor-elect, Jim Justice, announced that Jeff Sandy will serve as his secretary of WV Department of Military Affairs and Public Safety (DMAPS). Sandy is a Wood County native and currently a partner in Perry Forensic Investigations LLC, after working 25 years as a Special Agent with U.S. Treasury's Criminal Investigation Division. He is a Certified Fraud Examiner (CFE) and a Certified Anti-Money Laundering Specialist.

In 2008, Sandy was elected Sheriff of Wood County. As Sheriff, Sandy modernized his office with new equipment and new investigative strategies. He was appointed to serve on the Board of the Regional Jail Authority. In 2012, he was elected Chairman of the Regional Jail Board. Sandy also served on the Board of the West Virginia Sheriff's Association. He worked in Iraq on counter terrorism missions and to trace Saddam Hussein's hidden assets to keep them from being used by terrorists. His achievements were featured on ABC's World News Tonight. Since 9/11, Sandy has been part of the elite Department of Justice funded SLATT Team (State and Local Anti-Terrorism Training) that has trained over 140,000 United States law enforcement officers in all 50 states and Puerto Rico.

"I want the best and brightest to serve in my administration and Jeff Sandy's experience and qualifications are second to no one," said Governor-elect Jim Justice. "Jeff served our country and the people of Wood County with distinction and I am totally confident that he will continue his extraordinary service to the people of West Virginia. Jeff Sandy is prepared to keep West Virginians safe and make sure our state is ready to handle emergencies."

Jeff Sandy stated, "Governor-elect Justice and his team made it clear that they wanted to appoint someone for DMAPS that had international and domestic public safety experience; and in addition, had experience in private business. When the Governor-elect called me, and asked me to be his Secretary for DMAPS, it was an honor and an opportunity to give back to the state that I love. I assure the people of West Virginia that I will do everything in my power to keep West Virginians safe from foreign and domestic threats to our way of life."

During his time at U.S. Department of Treasury he earned over 100 awards, including: West Virginia Mid-Ohio Valley "Law Enforcement Officer of the Year", U.S. Department of Treasury Employee of the Year, and the second highest medal awarded by the Department of Defense, and the highest award issued by the Department of the Treasury for his investigative work in Iraq concerning the United Nations Oil for Food Fraud, Terrorism Funding, and the tracing of Saddam Hussein's hidden assets.

Jeff and his wife Renee have 3 children that are graduates of Marshall University. Ben and Matt are Certified Public Accountants, and Brittany is a school teacher specializing in special education.

### **JCHSEM to Develop Faith Based Organization Partnerships**

Faith-based Community Organizations (FBCO) partnerships are extremely important before, during and after disasters. During the 2016 Summer Flooding event in Southern West Virginia, it was the FBCOs that assisted their communities with comfort, care, sheltering, distribution of resources and information to their membership during the disaster, and many of those same FBCO representatives are now serving on Long-Term Recovery Committees that are planning a better tomorrow for their communities and assisting with still-unmet needs

In WV Homeland Security and Emergency Management provided a training, Mobilizing Faith-Based Community Organizations in Preparedness of Disasters on November 3 in Moorefield. Representatives from Jefferson County attended the training and want to move forward encouraging more involvement with our local FBCOs. JCHSEM has scheduled a meeting with FBCOs on Wednesday, January 11 at 1:00 p.m. at the Jefferson County Maintenance Department Meeting Room at 128 Industrial Blvd., Kearneysville, WV 25430.

Invited to the meeting are faith-based community organization (FBCO) representatives, emergency managers, and first responders to strategically mobilize and engage members of FBCOs, including religious charities, nonprofits such as the Salvation Army, the American Red Cross, churches (both affiliated and unaffiliated), temples, synagogues, mosques, and non-governmental organizations (NGOs) etc., in a reciprocal approach to disaster planning that is integrated into current local emergency management efforts. We hope to emphasize grassroots mobilization and coordination efforts as a means of engaging all faith communities, thereby reaching those marginalized communities most vulnerable to disaster, most frequently excluded from the planning process, and ultimately, most difficult to aid in recovery. We will introduces vital emergency management concepts to FBCO leaders, and educate emergency management/first responder communities about the critical role FBCOs can play in strengthening preparedness.

Over the next several months, the group will focus on what roles FBCOs are already playing in disasters. Examples are that the United Methodist Church has UMCOR, the Lutheran Church has the S.T.U.F.F. program, and one + program, Salvation Army provides mobile and congregate feeding and provides disaster counseling. The Red Cross assists with sheltering, damage assessments, and the safe and well program. These are just a few examples. At the meeting, we will discuss others! We will also focus on how FBCOs can get information from emergency management that they need during disasters, and opportunities for their congregations and members to prepare their own disaster supply kits and family disaster and communications plans before the next disaster.

JCHSEM has recently developed an updated list of FBCOs and will be sending out an email invitation for the meeting. However, if you are reading this and you are interested, you are invited to attend! Reverend Ed Grove, executive director of Habitat for Humanity said the Shepherdstown office will enable the organization to expand its goal of helping older and disabled residents to continue to live in their own homes. WV State Senator, John Unger is the Director of Development for Habitat and will spend much of his time in the new Shepherdstown office promoting the agency and working to expand the efforts in Jefferson County. He plans to work with agencies, such as Good Shepherd Caregivers in Shepherdstown, Jefferson County Community Ministries in Charles Town, and other area faith-based groups.

They are looking for volunteers and/or working with home construction projects. Director of Operations, Karin Hammann Dunn, said she will try to connect with Shepherd University students who are looking to perform service projects.

JCHSEM staff attended the official grand opening of the office. Barbara Miller, Director of JCHSEM indicated that "Habitat's disaster response has helped to provide shelter assistance, education, training, and partnerships to affected individuals who find themselves in terrible situations following a natural disaster. The loss of a home can leave you at your most vulnerable. Habitat has worked to rebuild communities in these circumstances, moving people and the community to recovery."

While we all strive to keep up with the latest technology, the best ways to work with stakeholders to develop plans, how to conduct successful floodplain management, performing damage assessments, how to handle the debris after a disaster, help our communities to recover, or just learning the fundamentals, there are plenty of options available to you. Here are some great opportunities for training that you may or may not know about:

West Virginia Military Affairs and Public Safety's Training Center, CourseMill. If you are involved in emergency management in West Virginia, you can set up your free account at http://www.onlinelearning.wv.gov/dmapscm6/home.html Once you set up your account, you can log on and

look at the list of available courses being taught in West Virginia. Current courses include the Basics of Floodplain Management, HazMat Highway Containers in a Tunnel Specialist, Search and Rescue in Community Disasters, Disaster Preparedness for Hospitals and HealthCare Organizations within the Community Infrastructure; National Emergency Management Basic Academy Train the Trainer; Advanced Floodplain Management Concepts, and Rail Care Incident Response for Crude, Ethanol and Other Flammable Liquids-Rail Car Response. The courses are always changing, so check back often.

**FEMA's Emergency Management Institute**'s url is https://training.fema.gov/emi.aspx. From this training portal, anyone can take their online independent study courses for free. There are over 100 courses to choose from. You can also browse the schedules and information about their on-campus resident courses for those who are involved in emergency management at the federal, state, local or tribal governments.

Jefferson County Homeland Security and Emergency Management uses NIXLE

Alerts to send emergency alert notifications by text, e-mail, Facebook and Twitter. We send out weather watches and warnings, as well as Emergency Public Information during disasters. Examples include tornado, flood, severe snowstorm, and severe thunderstorm watches, warnings, advisories, and emergen-

cies, as well as, where emergency shelters are located, where commodities can be obtained, etc. Signing up is easy and its FREE! To sign up, go to

http://local.nixle.com/register or text your zip code to 888777 and then text JCHSEM to the same number.

In addition to NIXLE, we still use traditional media, such as newspapers, TV, and radio, however, receiving NIXLE alerts on your phone is the fastest way to receive emergency public information. Make sure that everyone in your family that has a phone, receives our emergency alerts in case that you are not together when a disaster happens. Make receiving NIXLE Alerts a part of your family's communication plan. If you have questions about NIXLE Alerts, you can go to www.nixle.com and click on "resident". The Steering Committee works with the JCHSEM Director to guide the activities of JCHSEM. A fourteen-member Steering Committee is made up of public and private representation. JCHSEM is a Department within the Jefferson County Commission, who has overall responsibility for the department and its employees. The Jefferson County Commission appoints all members to the steering committee. This committee meets on the 4<sup>th</sup> Tuesday of February. March, May, June, August, September and holds a Nov/Dec meeting at 9:00 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced. The Quarterly Partnership meetings held in January, April, July, and October also serve as the Steering Committee meetings for those months.

#### Public Awareness, Education and Training Committee, Katherine Dunbar, Chair

Any interested person can serve on this committee. The Public Awareness, Education and Training Committee is responsible to communicate the organization's activities to the public and to build support for JCHSEM's programs. They work with the Director and other staff to keep the entire community focused on the objectives of JCHSEM, the opportunities for additional involvement and support by updating citizens and businesses about what the partners are doing and how the community will and is benefiting from these efforts. Additionally, they are responsible to assist the program manager is setting up speaking engagements and public awareness events. The Risk Assessment/Mitigation Planning Committee examine the community's risks and vulnerability to all hazards and assess the community's vulnerability to those risks. A Risk Assessment and Mitigation Plan was completed and adopted by the Jefferson County Commission, all Jefferson County municipalities, WVHSEM, and Federal Emergency Management Agency in July, 2003. The plan was updated in 2008 and 2013. The 2013 Plan was approved by WVDHSEM and FEMA in June, 2013. #### Counter Terrorism Committee, Barbara Miller, Director, Chair
