# OUR HISTORY AND OUR FUTURE

Jefferson County Homeland Security began under a FEMA Project Impact Grant in 2001 that funded the organization through mid-2004. The JCHSEM Steering Committee was designated by the Jefferson County Commission as the group that operates the Citizen Corps program within Jefferson County, including the Community Emergency Response Team (CERT) Program. In 2007, the County Commission merged JCOHS with the County's Emergency Management Department to form Jefferson County Homeland Security and Emergency Management.

<u>Our Committees</u>: Steering Committee that also serves as the County's Citizen Corps Council; Partnership and Volunteer Development; Public Awareness, Education and Training; All Hazards Risk Assessment & Mitigation Planning; and Counter Terrorism. Our department serves the Local Emergency Planning Committee (LEPC) for Information Coordination and Administration.
