# Jefferson County Emergency Services Agency Stop the Bleed Campaign

#### **Background:**

Motivated by the 2012 tragedy in Sandy Hook and multiple tragedies that have occurred in the ensuring years, what has become known as the Hartford Consensus has convened to bring together leaders from law enforcement, the federal government, and the medical community to improve survivability from manmade or natural mass casualty events. The resulting injuries from these events general present with severe bleeding which, if left unattended, can result in death. The participants of the Hartford Consensus concluded that by providing first responders (law enforcement) and civilian bystanders the skills and basic tools to stop uncontrolled bleeding in an emergency situation, lives would be saved. The first responder program has received very good response and is widely being used across the country. The next step is to focus on needs to civilian bystanders.

#### Need:

Civilians need basic training in bleeding control principles so they are able to provide immediate, frontline aid until first responders are able to take over care of an injured person. Due to many situations, there may be a delay between the time of injury and the time a first responder is on the scene. Without civilian intervention in these circumstances,

preventable deaths will occur.

#### **Mission/Objectives:**

The American College of Surgeons Committee on Trauma is leading the effort to save lives by teaching the civilian population to provide vital initial response to stop uncontrolled bleeding in emergency situations. This will be accomplished by the development of a comprehensive and sustainable bleeding control education and information program targeted to civilians that will inform, educate, and empower the 300+ million citizens of the United States.

#### Jefferson County, WV

This campaign will be spearheaded by the Jefferson County ESA. It was proclaimed by the Jefferson County Commission that on March 31st, the "Stop the Bleed" Campaign will be kicked off and this valuable education will start being taught in Jefferson County to school teachers, public officials, and interested members of the community.

#### PROCLAMATION

Whereas, the Jefferson County Emergency Services Agency ("JCESA") and Jefferson Medical Center ("JMC") are committed to broadening service in our community and lifelong educational learning;

Whereas, trauma is the leading cause of death for individuals under the age of 46;

Whereas, working with the private sector and nonprofit organizations, the "Stop the Bleed" campaign will put knowledge gained by first responders and our military, into the hands of the public to help save lives;

Whereas, no matter how rapid the arrival of trained emergency responders, bystanders will always be first on the scene;

Whereas, uncontrolled bleeding injuries can result from natural and manmade disasters and from everyday accidents. If this bleeding is severe, it can kill within minutes, potentially before trained responders can arrive;

Whereas, providing bystanders with basic tools and information on the simple steps they can take in an emergency situation to stop life threatening bleeding can save lives. Research has shown that bystanders, with little or no medical training, can become heroic lifesavers;

Whereas, similar to the use of CPR or automatic defibrillators, improving public awareness about how to stop severe bleeding and expanding personal and public access to Bleeding Control Kits can be the difference between life and death for an injured person;

Whereas, our community preparedness is the shared responsibility of all levels of government, the private and non-profit sectors, and individual citizens. The goal of this initiative is to build community resilience by empowering the general public to be aware of the simple steps that can be taken to stop or slow life threatening bleeding, and to promote the general public's access to Bleeding Control Kits in public spaces, while they travel, and in the home;

Whereas, this comprehensive and sustainable bleeding control education and information program will educate and empower the citizens of Jefferson County to save lives in an emergency situations;

Whereas, in partnership with the American College of Surgeons Committee, we pledge that our purpose of education will provide teachers and individuals the basic training in bleeding control principles so they are able to provide immediate, frontline aid until first responders arrive;

Be It Known that the County Commission of Jefferson County hereby proclaims March 31, 2018 as the "Stop the Bleed" Campaign Kick Off.



### 2018 Disaster Ready Kids Program

Do you have summer children's programs that you are looking for activities and/or readers for? We can help! Jefferson County Homeland Security and Emergency Management is once again sponsoring the Disaster Ready Kids Program for 2018.

This year we will be utilizing the "Mimi Mouse Learns to Prepare for Emergencies" DVD and accompanying materials. The Mimi Mouse program is designed for 4-7 year olds and provides general tips for parents on how to talk about emergencies, teaches children what an emergency kit is and how to build one, informs children about who to contact during an emergency, and how to review and practice for the family's emergency plan.

If your group of children is over the age of 8, we can have a preparedness presentation, show them how to put together a Family Disaster Kit, or work together to develop a unique lesson plan based on your needs. Our staff will come to your facility, present the chosen materials, and begin encouraging everyone to start thinking about emergencies in a positive and interactive way. The only requirements are that you have adults there to be responsible for the children while the activities are taking place, that you let us know how many children to prepare for (estimate), and that you work with us to schedule a time that works well for both organizations.



### Sign Up to Receive Nixle Alerts!



Jefferson County Homeland Security and Emergency Management uses NIXLE

Alerts to send emergency alert notifications by text, e-mail, Facebook and
Twitter. We send out weather watches and warnings, as well as Emergency
Public Information during disasters. Examples include tornado, flood, severe

snowstorm, and severe thunderstorm watches, warnings, advisories, and emergencies, as well as, where emergency shelters are located, where commodities can be obtained, etc. Signing up is easy and its FREE! To sign up, go to <a href="http://local.nixle.com/register">http://local.nixle.com/register</a> or text your zip code to 888777 and then text JCHSEM to the same number.

In addition to NIXLE, we still use traditional media, such as newspapers, TV, and radio, however, receiving NIXLE alerts on your phone is the fastest way to receive emergency public information. Make sure that everyone in your family that has a phone, receives our emergency alerts in case that you are not together when a disaster happens. Make receiving NIXLE Alerts a part of your family's communication plan. If you have questions about NIXLE Alerts, you can go to <a href="www.nixle.com">www.nixle.com</a> and click on "resident". #### **Volunteering Facts:**

- National Volunteer Week in the United States was first established via Presidential Proclamation 4288, signed by President Richard Nixon in 1974.
- Scientific studies have shown that individuals who volunteer enjoy psychological and physical benefits including increased satisfaction, improved sense of belonging, lower blood pressure, increased protection from Alzheimer's and decreased mortality.
- Volunteering is an excellent way to fill empty spaces on your resume and provide valuable life long knowledge and skills. Studies have shown that individuals who have volunteered are more likely to be hired over those who have never volunteered.
- Approximately 25 % of U.S. Citizens volunteer and on average volunteer for at least 40 hours per a year.

### Jefferson County All Hazards Mitigation Planning Committee Update

On Tuesday, March 27 at 1100 hours JCHSEM held the second meeting to continue working on the Jefferson County All Hazards Mitigation Plan.

The purpose of this plan is to better prepare Jefferson County to become more disaster resistant to natural and technological hazard events such as flooding, severe winter storms, and hazardous materials incidents. The plan is based on a hazard risk assessment, policies, and the development of mitigation goals (for the county, utilities, each municipality, etc.), objectives and strategies, as well as actions that can be taken to attain and maintain sustainability and disaster resiliency.

Development of this plan provides eligibility for future mitigation funds for Jefferson County and its citizens. Public participation in the development of

the All Hazards Mitigation Plan is essential to ensuring the safety and security of all those who work, live, and travel to Jefferson County.

During the first meeting the committee spoke about the changing priorities of the plan and set the overall mitigation goals for the plan, ones that the committee will strive to achieve through our mitigation projects. The committee discussed involving the public via online survey. The second meeting focused on reviewing and updating the hazards that affect Jefferson County.

The next meeting of the Jefferson County All Hazards Mitigation Planning Committee will be on Wednesday, April 18, at 1100 hours at the Jefferson County Maintenance Department Meeting Room. During this meeting, the committee will be discussing the following topics:

- Integration of existing plans into the hazard mitigation plan and vice versa
- New projects (each incorporated jurisdiction must have at minimum two projects)
- Plan maintenance process for the next five years.

### **Need Training?**

Emergency Management is a constantly-changing field. While we all strive to keep up with the latest technology, the best ways to work with stakeholders to develop plans, how to conduct successful floodplain management, performing damage assessments, how to handle the debris after a disaster, help our communities to recover, or just learning the fundamentals, there are plenty of options available to you. Here are some great opportunities for training that you may or may not know about:

West Virginia Military Affairs and Public Safety's Training Center, CourseMill. If you are involved in emergency management in West Virginia, you can set up your free account at <a href="http://www.onlinelearning.wv.gov/dmapscm6/home.html">http://www.onlinelearning.wv.gov/dmapscm6/home.html</a>

Once you set up your account, you can log on and look at the list of available courses being taught in West Virginia. Current courses include the Basics of Floodplain Management, HazMat Highway Containers in a Tunnel Specialist, Search and Rescue in Community Disasters, Disaster Preparedness for Hospitals and HealthCare Organizations within the Community Infrastructure; National Emergency Management Basic Academy Train the Trainer; Advanced Floodplain Management Concepts, and Rail Care Incident Response for Crude, Ethanol and Other Flammable Liquids-Rail Car Response. The courses are always changing, so check back often.

From this training portal, anyone can take their online independent study courses for free. There are over 100 courses to choose from.
