## JEFFERSON COUNTY ROAD NAME PETITION FORM

We the undersigned present this petition and request that action be taken administratively by the Jefferson County Addressing Office to consider the following indicated by check mark (X) and described below:

- ( ) **Assignment of a name to an unnamed road or shared right-of-way** (requires a majority, 50% + 1)
- ( ) **Change the name of an existing road** \_\_\_\_\_ (requires 80% of affected parcel owners).

We understand the purpose of this petition is to prevent and eliminate road name duplications and to assure the County that those residents and property owners along said roads have input in how it is named. Jefferson County's E9-1-1 Addressing Ordinance, Sections 4.2.1 and 4.6, in part authorizes the Jefferson County Commission to name or rename any public or private road.

## RULES FOR PETITION SIGNING

1. Petitioners must own property legally accessible from the common right right-of-way.
2. Only one member of each owner/residence needs to sign petition. **We must have the majority (50% plus one) of property owners sign before our office can review the petition.** *(In the event of an existing road name change request, we must have 80% of affected parcel owners sign)*
3. All property owners have one (1) vote regardless of how many lots are owned along the road.
4. If you own a rental property, please include your tenant's name, address and telephone number, so that they may be notified of the pending address change. Tenants shall not sign, nor vote.

**When choosing names, you should consider the impact to future sales and property values. Some names may have specific meaning to you but could disinterest or confuse future owners. Below are some guidelines by which our office reviews and approves/rejects suggested road names:**

**PROHIBITED:**

- **OFFENSIVE WORDS, TERMS OR PHRASES.**
- **PRECEDING NUMBERS (ie: Five Forks Road).**
- **DUPLICATES OR NAMES THAT SOUND TOO SIMILAR TO EXISTING ROAD NAMES.**
- **SYMBOLS (HYPHENS, APOSTROPHES, ETC.).**
- **CONJUNCTIONS SUCH AS 'AND' OR ARTICLES SUCH AS 'THE' (ie: Sarah AND George Drive).**
- **INITIALS AT THE BEGINNING OR END OF A NAME (ie: J Geils Drive).**
- **30 CHARACTER LIMIT ON ROAD NAMES.**

**DISCOURAGED:**

- **TRADEMARK NAMES, NOVELTY NAMES OR BRAND NAMES - DUE TO THEFT OF SIGNS**
- **PROFESSIONAL SPORTS NAMES AND CELEBRITY NAMES – DUE TO THEFT OF SIGNS**
- **FOREIGN NAMES, FAMILY NAMES AND WORDS THAT ARE DIFFICULT TO SPELL OR PRONOUNCE (may confuse the dispatcher when calling 911)**
- **ORDINAL DIRECTIONS THAT ARE NOT PREFIXES (ie: South Hills Drive, North Dakota Lane)**

**Please submit three (3) total names for each required road name; one (1) preferred name, plus two (2) alternatives in the event the desired road name is rejected. DIFFERENT SUFFIXES AFTER THE SAME NAME DO NOT CREATE SEPARATE CHOICES. (i.e. Joseph Lane, Joseph Way, Joseph Road)**
