# **JCHSEM Updating Prime Power Surveys**

Jefferson County Homeland Security and Emergency Management is encouraging all critical facilities in Jefferson County to complete a Prime Power Survey of emergency power needs to facilitate generator installation during catastrophic emergencies. This project was started in 2012, and many of the critical facilities have had generators installed since that time or have had other changes.


Prime power surveys determine power needs and electrical connection requirements at critical infrastructure, including the 9-1-1 Center/ Emergency Operations Center, the hospital, fire departments, police stations, the Emergency Services Agency, water plants and waste water treatment facilities, schools and buildings that are used as emergency shelters.

"The lesson learned from previous disasters was not to wait until you need emergency power to determine the size of the generator and equipment needed to install it," said Barbara Miller, Director of Homeland Security and Emergency Management. "Having this information pre-determined can significantly speed up efforts to provide emergency power during a wide-spread disaster."

The results of the power surveys will be put into the county's emergency management files and placed in the WV Division of Homeland Security and Emergency Management's database for power needs. Having this information in hand will allow county and state emergency managers to more efficiently direct resources to restore electrical power to these critical facilities during a major disaster, such as a derecho, tornado, or ice storm.

"Whether these facilities already have a generator or not, we need to have the form completed. Critical facility operators can get a copy of the Prime Power Survey by emailing either sniles@jeffersoncountywy.org or bmiller@jeffersoncountywv.org or by calling JCHSEM at 304-728-3329. ICHSEM hopes to have the surveys completed and returned by the end of June."





### **Jefferson County Preparedness Corner**

# June 1 is the beginning of the Atlantic Hurricane Season

June 1 is the start to the 2015 Atlantic Hurricane Season which makes June the perfect time to make sure we are all prepared by checking emergency supply kits and emergency preparedness plans!

While Jefferson County does not sit on a coastline, this does not make us immune to the reaching impacts of hurricanes and tropical storms. In 2003, Hurricane Isabel made landfall as a Category 2 storm on the Outer Banks. As the storm tracked north-eastward, wind and flooding damage was felt in North Carolina, Virginia, Maryland, District of Columbia, and here in Jefferson County, WV.



As recent as 2012, Hurricane Sandy (later named Super-storm Sandy) dumped over 3 feet of snow in parts of West Virginia which caused downed trees and power lines and disrupted transportation throughout the state. Locally, in Jefferson County, Sandy caused major flooding along the Opequon Creek which led to evacuations of that area. The major threats from tropical systems to Jefferson County include (but are not limited to) flooding, power outages, road closures, and possible disruption to water service.



With these things in mind, everyone should have a home emergency supply kit and plan in the event a storm comes our way. Kits should include supplies for power outages (flashlights, battery operated lanterns), potable water, easy to prepare meals, medicines and first aid kit, and other essentials for your comfort. Emergency plans are as simple as knowing two ways out of every room in case of fire, a safe meeting place outside the home and outside of the neighborhood, and finally a communication plan to reunite everyone in your household back together. In all of the planning

for your family, please remember your furry household members. Have pet supplies on hand along with veterinary documents. In the event of an evacuation, check with your community shelter to ensure you can bring your pets to the shelter facility.

# **Recommended Independent Study Courses for June, 2015**

Each month, JCHSEM recommends one or more of the FEMA Independent Study Courses for all volunteers to take to increase their knowledge base. The course chosen for June is: IS-288a The Role of Voluntary Agencies in Emergency Management. This independent study course provides a basic understanding of the history, roles and services of disaster relief voluntary agencies in providing disaster assistance. It is appropriate for both the general public and those involved in emergency management operations. Course Objectives:

The overall goal of this Independent Study course is to increase awareness of the roles and responsibilities of voluntary agencies in emergency management. Voluntary agencies have helped meet the needs of individuals and communities affected by disasters since the 1800's. Today, they serve a critical role in the emergency management field from helping communities prepare for and mitigate the effects of disasters to providing immediate response and long-term recovery services. Without the support, dedication, and expertise of voluntary agencies, the government would be unable to address all the needs of disaster-affected communities.

# 2015 Disaster Ready Kids Program

Do you have summer children's programs that you are looking for activities and/or readers for? We can help!

Jefferson County Homeland Security and Emergency Management is once again sponsoring the Disaster Ready Kids Program for 2015.

This year we will be utilizing the "Mimi Mouse Learns to Prepare for Emergencies" DVD and accompanying materials. The Mimi Mouse program is designed for 4-7 year olds and provides general tips for parents on how to talk about emergencies, teaches children what an emergency kit is and how to build one, informs children about who to contact during an emergency, and how to review and practice for the family's emergency plan.

If your group of children is over the age of 9, we can show them how to put together a Family Disaster Kit or a Pet Disaster Supply Kit.

Our staff will come to your facility, present the chosen materials, and begin encouraging everyone to start thinking about emergencies in a positive and interactive way. The only requirements are that you have adults there to be responsible for the children while the activities are taking place, that you let us know how many children to prepare for (estimate), and that you work with us to schedule a time that works well for both organizations.

There is no cost to participate in this program.



# The Strategic Foresight Initiative

The emergency management community faces a future with challenges likely to be far different from those we confront today. Powerful drivers of change such as globalization, technological development, and the changing roles of individuals in society have real potential to reshape the context within which we will operate. Addressing these transformations will be challenging; confronting the complexity that arises from the interaction of multiple drivers – such as demographic shifts, technology, environmental changes, and economic uncertainty – will require entirely new approaches, tools, and capabilities. Public safety, public security, and disaster management organizations have already taken some steps to address these emerging challenges. However, the increasing pace and complexity of change calls for inclusive engagement and action so that we can proactively plan for and address shifting trends together, as a community of practice. To do this requires the emergency management community to establish and maintain a foresight capability. Foresight does not promote a singular vision or prediction. Instead, it considers a broad spectrum of plausible outcomes to help inform decision-making under uncertain conditions.

The Federal Emergency Management Agency (FEMA) established the Strategic Foresight Initiative (SFI) to address this need. This initiative has brought together a wide cross-section of the emergency management community to explore key future issues, trends and other factors, and to work through their implications. Working collaboratively and with urgency, we are beginning to understand the full range of changes we could encounter and the nature of our future needs; and we can begin to execute a shared agenda for action.

This report presents the findings from foresight efforts thus far, including: uncertainties that define and drive the future environment; strategic needs and gaps our community will have to address; a look into the emergency management community of 2030; and finally, suggested next steps for the community to prepare for the future. The strategic needs in particular – grouped into Essential Capabilities, Innovative Models and Tools, and Dynamic Partnerships – are intended as a catalyst for leaders throughout the emergency management community to prepare themselves and the Nation for the challenges and opportunities the future holds.

The products of this foresight initiative are offered as a starting point for dialogue and active consideration throughout the emergency management community. The thoughts and ideas presented in this report do not encompass all of the nuances and situations we will meet in the future. Rather, they offer a foundation for developing a shared understanding of potential future challenges and how, working together, we may address these challenges.

The work of the SFI is not possible without the participation of many dedicated professionals from across the United States, spanning many fields and disciplines, as well as our international colleagues. These contributions have already generated tremendous knowledge and insight, and will carry this work forward to meet our shared future demands.

### Steering Committee, John Sherwood, Chair

The Steering Committee works with the JCHSEM Director to guide the activities of JCHSEM. A fourteen-member Steering Committee is made up of public and private representation. JCHSEM is a Department within the Jefferson County Commission, who has overall responsibility for the department and its employees. The Jefferson County Commission appoints all members to the steering committee. This committee meets on the 4<sup>th</sup> Tuesday of February. March, May, June, August, September and holds a Nov/Dec meeting at 9:00 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced. The Quarterly Partnership meetings held in January, April, July, and October also serve as the Steering Committee meetings for those months.

Any interested person can serve on this committee. The Public Awareness, Education and Training Committee is responsible to communicate the organization's activities to the public and to build support for JCHSEM's programs. A Risk Assessment and Mitigation Plan was completed and adopted by the Jefferson County Commission, all Jefferson County municipalities, WVHSEM, and Federal Emergency Management Agency in July, 2003. The plan was updated in 2008 and 2013. The 2013 Plan was approved by WVDHSEM and FEMA in June, 2013. This committee meets Quarterly. Please call the office for exact dates and times.

### Counter Terrorism Committee, Barbara Miller, Director, Chair
