"Operation Crazy Train" LEPC Tabletop Exercise Simulated a Train Derailment, Major Fire, Hazardous Materials and Mass Fatalities

Over 40 people gathered on April 30th to participate in the Jefferson County LEPC's Tabletop Exercise, "Crazy Train". The scenario was a derailed train, a major fire, hazardous materials, and mass fatalities. It was held at the new Jefferson County Maintenance Department's meeting room in Bardane.

"Everything they came up with is a real possibility and I think the worst case scenario is what you should study and get people working together so they know what they are supposed to do," said Dr. Bob Johnson, Chairman of the Jefferson County Board of Health, who was a participant in the exercise.

The tabletop exercise enabled emergency responders and emergency management personnel to work through the exercise injects face-to-face.

"The purpose of a tabletop exercise is to go through our plans, policies and procedures to identify any weaknesses that we might have and to meet those that everyone will be working with when a real event happens," said Jennifer Maggio, Public Information Officer for Jefferson County Homeland Security and Emergency Management.

"Norfolk-Southern Railway assisted the planning team for the exercise to make it as real as possible, based upon chemicals that regularly are transported through our community. While safety is a main priority of those who transport hazardous materials, there is always a chance that something can go very wrong," said Jefferson County Homeland Security and Emergency Management Director, Barbara Miller. "Everyone here has a common goal of protecting lives, protecting property and the environment, and protecting our community. Everyone worked well through the scenarios and ended the evening by identifying strengths and weaknesses."

Jennifer Lee, from WHAG-TV, Hagerstown, covered the exercise, which aired on April 30, 2012.

Representatives from FEMA were visiting Jefferson County's mitigated properties recently. There are properties where the County did mitigation projects during the late 1990's so that future floods would not be harmful to those properties. The County had to agree to keep these properties as Open Space forever. FEMA representatives visit the properties every two years to assure that we are holding up to our end of the bargain.

Watch your June issue of this newsletter for information about the 2013 Jefferson County Multi-Jurisdictional All Hazards Plan and THIRA update. The Mitigation Committee will reconvene in June to review our current plan and projects, as required and start moving towards the new plan. This plan, updated and revised every 5 years, is a requirement for all communities so that they can receive FEMA funds after a disaster. Additionally, if the community receives any funds for the Flood Mitigation Assistance Program, the Severe Repetitive Loss Program, the Repetitive Flood Claim Program, the Pre-Disaster Mitigation Grant Program, or the Hazard Mitigation Grant Program, this plan is also a requirement. Jefferson County is a Community Rating System of the National Flood Insurance Program and receives a number of points towards its reduction of flood insurance rates to residents, due to the planning process and contents of our Risk Assessment and Mitigation Plan. The planning committee is made up of agencies, private businesses, representatives of county and local governments, non-governmental agencies, PSDs, responder agencies, and other interested parties. Mason Carter, Jefferson County's Floodplain Manager, serves as the Chairman of the Mitigation Committee.

THIRA-The Threat and Hazard Identification and Risk Assessment has been anticipated new guidance. The THIRA process provides a common way to more fully understand all of the risks communities face and is now required for homeland security and emergency management grantees. The process ties the risk of a threat or hazard to capabilities to look at gaps as a part of a comprehensive preparedness cycle. What makes THIRA unique is that it doesn't just look at natural hazards or terrorist threats. Instead it takes into account the threats and hazards that pose the greatest risk to a community—regardless of the cause. The preparedness guide lays out a five-step process on how to do that, and it is adaptable to the needs and resources of our local, and state homeland security and emergency management partners. The five steps are:

- ⇒ Identify the threats and hazards of concern—What could happen in my community?
- ⇒ Give the threats and hazards context-Describe how a threat or hazard could happen in my community, and when and where it could happen.
- ⇒ Examine the core capabilities using the threats and hazards-How would each threat or hazard affect the core capabilities identified in the National Preparedness Goad?
- ⇒ Set Capability Targets-Using the information above, set the level of capability a community needs to prevent, protect against, mitigate, respond to, and recover from its risks
- ⇒ Apply the results-Use the capability targets to decide how to use resources from the Whole Community. Throughout the THIRA process, our goal is for communities to find out what data and information they should check regularly and keep updated so that they can recognize when their community's threats and hazards change. THIRA helps jurisdictions focus on key information about their community and how that jurisdiction and community interacts with its partners at all levels. It is important to note that while the THIRA will be used to inform resource allocation and planning, the THIRA will not replace hazard mitigation plans. The THIRA will take into account these plans.

May is National Pet Month 10 Ways to Celebrate and Prepare your Pet for Disasters

What better time to prepare your pets for future disasters than during May, which is National Pet Month! Jefferson County Homeland Security and Emergency Management offers the following advice to help you with your planning:

- 1. If you are like most Americans, your pets ARE family, so include the needs of your pets in your family's disaster planning. Who will be able to take care of your pet if something happens while you are away from home and you can't get back to him or her? If you should have to evacuate from your residence, have you identified pet-friendly hotels to stay in along the way to your family's identified back up location? Is your pet tagged or micro-chipped to identify it in case you should get separated? Do you have your vet's contact information on your cell phone?
- 2. Include a disaster supply kit for your pets, as well as your human family. Your pets needs will include food and water for at least a week; some favorite toys; a leash/harness; a pet carrier with plenty of room for him to move around and contact info for you; a pet first aid kit; a copy of the pet's vet records/proof of vaccinations; and pictures of you with your pet, in case you are separated.
- 3. Keep your pets up-to-date on their vaccinations. Keep their rabies tags and ID tags on them, and have a hard copy of proof of vaccinations in case of emergencies.
- 4. Take a class to learn more! FEMA (The Federal Emergency Management Agency) offers there IS-10, Animals in Disaster-Preparedness and Awareness Course online for free. You can find it at http://training.fema.gov/EMIWeb/IS/is10a.asp
- 5. The American Veterinary Medical Association has a booklet, available in both English and Spanish called, "Saving the Whole Family" that has lots of tips on preparing pets for disasters. You can download it for free at https://ebusiness.avma.org/EBusiness50/ProductCatalog/product.aspx?ID=140 for the English version. - 6. Ready.gov has a brochure, titled, "Preparing your Pets for Emergencies Makes Sense-Get Ready Now. Also free from: http://www.ready.gov/sites/default/files/documents/files/pets brochure.pdf
- 7. Remember your pet's sanitation needs when planning and keep needed supplies in your pet disaster kit.
- 8. Contact the American Red Cross for information and costs of their Pet First Aid Books. They have one for cats and one for dogs.
- 9. Consider becoming trained by the Humane Society of the United States to become a member of the National Disaster Animal Response Team. Find out more at http://www.humanesociety.org/issues/animal rescue/ndart/ndart.html

Jefferson County Homeland Security and Emergency Management-Committees

Steering Committee, John Sherwood, Chair

The Steering Committee works with the JCHSEM Director to guide the activities of JCHSEM. A fourteen-member Steering Committee is made up of public and private representation. JCHSEM is a Department within the Jefferson County Commission, who has overall responsibility for the department and its employees. The Jefferson County Commission appoints all members to the steering committee. This committee meets on the 4th Tuesday of February. March, May, June, August, September and holds a Nov/Dec meeting at 9:00 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced. The Quarterly Partnership meetings held in January, April, July, and October also serve as the Steering Committee meetings for those months.

Animals in Disaster Committee, Kelly Parsons, Chair

Any interested person can serve on this committee. The Animals in Disaster Committee is responsible for developing and updating the Animals in Disaster Plan and to work with the JCHSEM to make recommendations regarding the Animals Annex of the Emergency Operations Plan. They will also identify potential resources for animals before, during and after a disaster. The committee meets on the 3rd Monday of the months of January, April, July, October at 9:30 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.

Emergency Planning for People with Special Needs Committee-Amy Jones, Chair

Any interested person can serve on this committee. The Emergency Planning for People with Special Needs Committee is responsible for training and planning for issues of people who have mobility problems, people who have sight or hearing problems, people who speak a language other than English as their first language, the elderly and the very young, people who use oxygen or other medical devices and anyone who may need special assistance during times of disasters and/or evacuations. This committee will work with the JCHSEM to update the portion of the Emergency Operations Plan that deals with these special needs. This committee meets on the 3rd Monday of the months of March, June, September, and December at 9:30 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced. This room IS handicapped accessible.

Public Awareness, Education and Training Committee, Katherine Dunbar, Chair

Any interested person can serve on this committee. The Public Awareness, Education and Training Committee is responsible to communicate the organization's activities to the public and to build support for JCHSEM's programs. They work with the Director and other staff to keep the entire community focused on the objectives of JCHSEM, the opportunities for additional involvement and support by updating citizens and businesses about what the partners are doing and how the community will and is benefiting from these efforts. Additionally, they are responsible to assist the program manager is setting up speaking engagements and public awareness events. This committee meets on the 2nd Wednesday of each month except December at 8:30 a.m. in the EOC at 28 Industrial Blvd., Kearneysville unless otherwise announced.

Partnership and Volunteer Development Committee, Holly Morgan-Frye, Chair

Any interested person can serve on this committee. The Partnership Development committee assists the staff in identification and recruitment of potential partners and what they have to offer in community preparedness. This committee will be responsible for activities to promote partnership or membership development and recruitment of volunteers. This committee meets quarterly in the EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced at 8:30 a.m. on the last Monday of January, April, July and October.

Risk Assessment and Mitigation Planning Committee, Mason Carter, Chair

Any interested person may serve on this committee. The Risk Assessment/Mitigation Planning Committee will examine the community's risks and vulnerability to all hazards and assess the community's vulnerability to those risks. Additionally, they will look at specific buildings, infrastructure, etc. to determine which are most susceptible to risks. A Risk Assessment and Mitigation Plan was completed and adopted by the Jefferson County Commission, all Jefferson County municipalities, WVOHSEM, and Federal Emergency Management Agency in July, 2003; updated the original document in 2008. Next update in 2013. This committee meets on an "as needed basis". Please call the office at 728-3329 for exact dates and times.

Counter Terrorism Committee, Barbara Miller, Director, Chair

Membership to this sub-committee of the Risk Assessment and Mitigation Planning Committee is limited to members of law enforcement, emergency management, homeland security, emergency communications, Red Cross, schools, health care, fire companies, ambulance authority/EMS, and government, due to sensitive homeland security issues. The committee works on issues of planning and training for counter terrorism or human-caused disasters. Meetings are held on the 2nd Tuesday of the month at the EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.
