

- For many, the New Year is a time for making resolutions and goals for the year to come. Spend more time with the family, lose 10 pounds, exercise more and/or reduce debt are resolutions that appear on many of our lists, but the Federal Emergency Management Agency's (FEMA) *Ready* Campaign is asking you to *Resolve to be Ready* by making an emergency preparedness resolution.
- Americans who make New Year's resolutions are 11 times more likely to report continued success changing a problem than comparable individuals who have not made a resolution, according to the *Journal of Clinical Psychology*. The *Ready* Campaign would like to make an emergency preparedness resolution easy to keep by providing the tools and resources needed to take the three important steps: get a kit, make a plan and be informed about the different types of emergencies that could occur in your area and their appropriate responses.
- Flooding, winter storms, wildfires and earthquakes no matter what Mother Nature has in store, preparing ahead of time can help to protect against her nastier surprises, speed recovery, and reduce losses not to mention regrets. By following the *Ready* Campaign's three steps, preparing for an emergency can be a simple and realistic resolution you can keep all year long. You and your family can update or initiate your own emergency preparedness plan, build your own supply kit and be ready for winter storms, spring nor'easters or summer power outages.
- Free preparedness resources, such as a Family Emergency Plan template and an Emergency Supply Kit Checklist are just a click away at <u>www.Ready.gov</u> or <u>www.listo.gov</u>. The *Ready* Web site also has a special section for kids, ages 8-12, (*Ready* Kids) and small- to medium-sized businesses (*Ready* Business).
- Emergencies will happen, but taking action now can help us minimize the impact they will have on our lives. Preparedness is contagious. What starts with one family can spread throughout a neighborhood, and every prepared community frees up emergency responders to take care of those who are in dire need. Preparedness is a shared responsibility; everyone is going to have to play a role. So *Don't Drop the Ball, Resolve to be Ready in 2011.*



# Preparing for Success: Preparedness & Grant Planning Workshop (Region 3)



WV Department of Military Affairs and Public Safety has announced that they will be holding a series of Grant Planning Workshops throughout the state to prepare those who plan to ask for Homeland Security funding. The workshop for WV Homeland Security Region 3 will be held on February 3 at the North Fork Mountain Inn at Smoke Hole from 10:00 a.m.—2:30 p.m. The purpose of this workshop is to help leaders, managers, and planners in public safety, emergency management, and homeland security arenas develop a better understanding of the Target Capabilities List (TCL) and how the TCL supports state and local preparedness and planning efforts in concert with the homeland security grants process. This knowledge is important as the U.S. Department of Homeland Security (DHS) is placing greater emphasis on using the TCL to measure preparedness and the effectiveness of homeland security grant programs.

The "Preparing for Success" workshop is intended to help participants understand homeland security initiatives and develop a working knowledge of the utility of the target capabilities in planning, training, exercises, grant requests, and other preparedness activities. The long term goal of this workshop is to build preparedness capabilities within the State of West Virginia through: a.) a better understanding of national strategies and initiatives; b.) an appreciation of the relationship between national strategies and the preparedness of state and local jurisdictions; c.) enhanced collaboration among local, state, and federal agencies and departments; and d.) the development of a working understanding of the homeland security grants program. # JCHSEM Counter Terrorism Committee to meet at American Public University System's New Academic Center in Charles Town

Jefferson County Homeland Security and Emergency Management's Counter Terrorism Committee will hold their January meeting at American Public University System's new Academic Center in Charles Town on February 8th. Dr. Frank McCluskey will speak to the group about APUS, their Homeland Security and Emergency Management programs, and their experiences since they've become a part of the Jefferson County Community. Below is a recent news release about APUS:

*Charles Town, W.Va.,* <u>American Public University System</u> (APUS) opened its new, energy-efficient academic center in the heart of Charles Town, West Virginia. APUS is a regionally and nationally accredited online institution of higher education operating through two universities, <u>American Military University</u> (AMU) and <u>American Public University</u> (APU), which educate more than 75,000 adult learners worldwide.

"The new academic center will further enable faculty and staff to collaborate in supporting and educating thousands of aspiring students," said APUS President & CEO Dr. Wallace E. Boston. "By empowering our students to identify new opportunities, analyze risk, and seek innovative approaches to problems, we are helping prepare them for leadership in a rapidly changing world."

Highlights of the 45,000-square foot, four-story brick facility include the following:

- Meeting and office space for more than 140 APUS faculty, academic staff and student advisors;
- A library with one of the nation's major collections for research in military studies and military history; and
- Energy-efficient design featuring advanced thermal insulation of windows and walls, variable lighting and cooling to manage energy use, and solar panels to provide a portion of energy requirements.

APUS will seek gold-level certification in Leadership in Energy and Environmental Design (LEED) for the facility, which was constructed to standards set by the U.S. Green Building Council. "The environmentally-friendly features employed in construction and in material selection were designed to reduce greenhouse gas emissions and contribute to a healthier work environment for employees and a cleaner environment overall for the community of Charles Town and Jefferson County," noted Dr. Boston.

"Integral to the APUS mission is a commitment to expanding access to affordable online higher education in a manner that supports local communities and respects the environment," added Dr. Boston. APUS is a charter signatory of the American College and University Presidents Climate Commitment – a promise to work toward reducing the online institution's already low carbon footprint in the years to come. This includes the use of environmentally-friendly office products, an extensive recycling program, and the use of two electric vehicles for local business travel.

Located in the center of the *Charles Town – Ranson "Commerce Corridor"*, a 1.5 mile segment with more than a dozen abandoned and under-utilized Brownfields slated for new office and retail development, the new "green" facility represents a major economic investment in the downtown area. At the same time, the building's architecture is designed to preserve and complement the character and history of Charles Town with a blend of old and new design elements.

Congratulating APUS and the Charles Town-Ranson community on their achievement, U.S. Environmental Protection Agency (EPA) Assistant Administrator Mathy Stanislaus stated, "Charles Town and Ranson have developed a vision for the Commerce Corridor as an area-wide brownfields plan, and this APUS Academic Center is the first step towards a broader revitalization of the Commerce Corridor. It is because of this track record of success in redeveloping brownfields in the Commerce Corridor that the EPA selected Ranson as one of 23 pilot communities to receive assistance under our new Brownfields Area-Wide Planning Pilot Program."

Since 2002, APUS has renovated several local buildings, including the former County Office Building, the former Jefferson County Hospital and Knott Nursing Home, the former Acme grocery building and ABC building, the former Avanti Restaurant, and the former home of Mayor Thomas Claiborne Green, one of John Brown's defense attorneys. With the addition of the new academic center, the university owns or leases 15 properties in Charles Town.

JCHSEM is a Department within the Jefferson County Commission, who has overall responsibility for the department and its employees. #### Animals in Disaster Committee, Kelly Parsons, Chair

Any interested person can serve on this committee. The Animals in Disaster Committee is responsible for developing and updating the Animals in Disaster Plan and to work with the JCHSEM to make recommendations regarding the Animals Annex of the Emergency Operations Plan. They will also identify potential resources for animals before, during and after a disaster. The committee meets on the 3<sup>rd</sup> Monday of the months of January, April, July, October at 9:30 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.

### Emergency Planning for People with Special Needs Committee-Chair -Pamela Holstein-Wallace, Chair

Any interested person can serve on this committee. The Emergency Planning for People with Special Needs Committee is responsible for training and planning for issues of people who have mobility problems, people who have sight or hearing problems, people who speak a language other than English as their first language, the elderly and the very young, people who use oxygen or other medical devices and anyone who may need special assistance during times of disasters and/or evacuations. This committee will work with the JCOHSEM to update the portion of the Emergency Operations Plan that deals with these special needs. This committee meets on the 3<sup>rd</sup> Monday of the months of March, June, September, and December at 9:30 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced. This room IS handicapped accessible.

## Public Awareness, Education and Training Committee, Katherine Dunbar, Chair

Any interested person can serve on this committee. The Public Awareness, Education and Training Committee is responsible to communicate the organization's activities to the public and to build support for JCHSEM's programs. They work with the Director and other staff to keep the entire community focused on the objectives of JCHSEM, the opportunities for additional involvement and support by updating citizens and businesses about what the partners are doing and how the community will and is benefiting from these efforts. Additionally, they are responsible to assist the program manager is setting up speaking engagements and public awareness events. This committee meets on the 2<sup>nd</sup> Wednesday of each month except December at 8:30 a.m. in the EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.

## Partnership and Volunteer Development Committee, Holly Morgan-Frye, Chair

### Risk Assessment and Mitigation Planning Committee, Mason Carter, Chair

Any interested person may serve on this committee. The Risk Assessment/Mitigation Planning Committee will examine the community's risks and vulnerability to all hazards and assess the community's vulnerability to those risks. Additionally, they will look at specific buildings, infrastructure, etc. to determine which are most susceptible to risks. A Risk Assessment and Mitigation Plan was completed and adopted by the Jefferson County Commission, all Jefferson County municipalities, WVOHSEM, and Federal Emergency Management Agency in July, 2003. The committee currently updated the original document. This committee meets on an "as needed basis". Please call the office at 728-3329 for exact dates and times.

#### Counter Terrorism Committee, Barbara Miller, Director, Chair

Membership to this sub-committee of the Risk Assessment and Mitigation Planning Committee is limited to members of law enforcement, emergency management, homeland security, emergency communications, Red Cross, schools, health care, fire companies, ambulance authority/EMS, and government, due to sensitive homeland security issues. The committee works on issues of planning and training for counter terrorism or human-caused disasters. Meetings are held on the 2<sup>nd</sup> Tuesday of the month at the EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.
