EPOCC to Develop a Regional Animals in Disaster Annex

The Eastern Panhandle Office of Emergency Management Coordinating Committee (EPOCC) will work together to develop one Regional Animals in Disaster Emergency Operations Plan Annex that will be used by all seven counties. The counties that make up EPOCC are Jefferson, Berkeley, Morgan, Hampshire, Hardy, Grant and Mineral. The group recently was awarded a \$15,000 Homeland Security Grant from the State Administrative Agency to hire a contractor to work with them to develop the annex and identify all of the animal resources in the region. The annex will address domestic pets, agricultural animals, service animals, and unique animal issues that face the Eastern Panhandle region. "We all have similar issues when it comes to dealing with pets and other animals during disasters," said Barbara Miller, Jefferson County's Emergency Manager. "If you think back to Hurricane Katrina, you will remember seeing pictures of dogs and cats that had been left behind when their owners had to evacuate. Additionally, some people refused to evacuate because they couldn't take their pets with them. Humane groups worked for months to rescue animals after that disaster and to try to identify and reunite found animals with their owners. Thus, the PETS Act (The Pets Evacuation and Transportation Standards Act of 2006 was born, which now requires all jurisdictions to include pets in their disaster planning, among other things. We are all facing even more difficult times planning for emergencies when all of the local animal shelters are full. There are different challenges when the economy isn't as strong as it once was. Rather than all of us struggling with the same requirement, we have decided to work on it together and look at it from a regional perspective." A Request for Proposals has been released. Any company wishing to receive a copy of the RFP or if there are people or groups in the region that would like to participate in the planning process, they can contact their local county emergency manager. The plan should be complete by mid-August, 2011.



Community Mourns the Loss of K-9 Andy

The community is mourning the loss of Jefferson County Sheriff's Department K-9 officer, G.W. Kilmer's longtime fourlegged partner, a retired police canine named "Andy" who passed away from unexpected health problems. Kilmer, a sixyear veteran of the Sheriff's Department, said the purebred long-haired German Shepherd passed away after undergoing emergency surgery in Winchester, Va. "His stomach was flipped and we rushed him to Winchester. He made it through the surgery fine, and then I guess he had heart failure," Kilmer said. Andy, who came from Czechoslovakia, was Kilmer's partner on the road for about three and a half years. The police canine was allowed to retire about five months ago after he was diagnosed with spinal arthritis. Andy conducted drug work, building searches, tracking and other duties while he was a member of the police force. Kilmer estimated that Andy was responsible for at least \$300,000 in narcotic seizures during his career. The officer, who now works with a new police canine named "Max," said he plans to have Andy cremated, and will keep his beloved friend's ashes. He also asked anyone who would like to honor Andy's memory to make a donation to the Briggs Animal Adoption Center in Jefferson County. The nonprofit center provided free food and medical care to Andy for his entire life, even taking care of the more than \$4,000 surgery prior to the animal's unexpected death. "Since Briggs put so much money into this dog, I'd ask if anybody who is a dog lover to give donations to Briggs," Kilmer said. "They've done a lot for us. Jefferson County Officials Attend Security Conference

Several Jefferson County officials recently attended a conference in Charleston to discuss methods to improve courthouse security. The conference, which brought together over 70 people from around the state, was funded by a grant from the West Virginia Court Security Fund, took place February 22-24, 2011. "The Supreme Court and the Administrative Office are concerned about the safety

"The Supreme Court and the Administrative Office are concerned about the safety and well-being of judicial employees, county employees and the public who access Judicial buildings every day," said Angela Saunders, director of court services. "The purpose of this conference is to provide training to the counties on emergency preparedness and court security, provide technical assistance and work out ways to communicate better with each other and the administrative office." The Supreme Court asked that each county designate two people to be in charge of security planning at each court facility in case of a disaster. Jefferson County was represented by Ed Boober, former sheriff and chairman of the committee; Magistrate Gail Boober; public defender, John McFarland; head bailiff and co-chair of the security team, Louis Brunswick; and Barbara Miller, director of Homeland Security and Emergency Management. Jefferson County was one of five counties in the state to be chosen as a test county in preparation for emergency planning to be implemented in al 55 counties. "There is an interest in responding to emergencies that could occur in our community," said Ed Boober. "In spite of the emergency, we need to continue our services to the community and relocate to other sites for short and long periods of time and then return to business as usual when the emergency has ended." he said. The conference hosted several nationally recognized experts in court security, including Timm Fautsko, principal court management consultant for the National Center for State Courts; Jessica Pitts, director of emergency preparedness and court security for the Maryland Judiciary; and Zygmont Pines, Pennsylvania court administrator. "We want Jefferson County to be proactive in the security of the courts, and we find that in the partnership of joining these different entities involved we are raising issues we would have otherwise not thought about," Gail Boober said. "It's an honor to be one of the first counties chosen to help others in the state plan for emergencies."

C.E.R.T. Training to start in March

The **Emergency Response Guidebook 2008 (ERG2008)** is primarily a guide to aid first responders in quickly identifying the specific or generic hazards of the material(s) involved in the incident, and protecting themselves and the general public during the *initial response phase* of the incident. Skywarn Stormspotter Basics I Class

The National Weather Service in Sterling, VA and JCHSEM will host a NWS Basics I Skywarn Stormspotter Class this spring. The Basics I class is the starting point for all new Stormspotters and is a prerequisite for all other WEATHER.GOV. Stormspotter Classes. Skywarn Stormspotters are the first line of defense against severe weather in their community. Once you have completed the course, you are eligible to volunteer with NWS to assist them to verify what their Doppler radar is and is not telling them. You will be issued a Stormspotter number and learn how and what to report. We are currently working with NWS officials and the date and place for this class will soon be announced. This 2-day course is intended to equip emergency management staff and voluntary agency personnel with the knowledge and skills necessary to perform as effective mass care coordinators in a broad range of disaster situations. The course covers how to assess and size up mass care needs; how to plan for mass care; recruitment, training, and exercises for mass care personnel; and actions to take in short-term and long-term mass care operations (response and recovery). This training is offered through the WV Division of Homeland Security and Emergency Management. If interested, you must fill out a training request form (can be found on either the WVDHSEM website or the JCHSEM website). The form must be signed by your local emergency manager before being forwarded on to WVDHSEM training officer, Herb Lattimore. Steering Committee, John Sherwood, Chair

The Steering Committee works with the JCHSEM Director to guide the activities of JCHSEM. A fourteen-member Steering Committee is made up of public and private representation. JCHSEM is a Department within the Jefferson County Commission, who has overall responsibility for the department and its employees. The Jefferson County Commission appoints all members to the steering committee. This committee meets on the 4th Tuesday of each month at 8:30 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.

Animals in Disaster Committee, Kelly Parsons, Chair

Any interested person can serve on this committee. The Animals in Disaster Committee is responsible for developing and updating the Animals in Disaster Plan and to work with the JCHSEM to make recommendations regarding the Animals Annex of the Emergency Operations Plan. They will also identify potential resources for animals before, during and after a disaster. The committee meets on the 3rd Monday of the months of January, April, July, October at 9:30 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.

Emergency Planning for People with Special Needs Committee-Chair - Pamela Holstein-Wallace, Chair

Any interested person can serve on this committee. The Emergency Planning for People with Special Needs Committee is responsible for training and planning for issues of people who have mobility problems, people who have sight or hearing problems, people who speak a language other than English as their first language, the elderly and the very young, people who use oxygen or other medical devices and anyone who may need special assistance during times of disasters and/or evacuations. This committee will work with the JCOHSEM to update the portion of the Emergency Operations Plan that deals with these special needs. This committee meets on the 3rd Monday of the months of March, June, September, and December at 9:30 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced. This room IS handicapped accessible.

Public Awareness, Education and Training Committee, Katherine Dunbar, Chair

Any interested person can serve on this committee. The Public Awareness, Education and Training Committee is responsible to communicate the organization's activities to the public and to build support for JCHSEM's programs. They work with the Director and other staff to keep the entire community focused on the objectives of JCHSEM, the opportunities for additional involvement and support by updating citizens and businesses about what the partners are doing and how the community will and is benefiting from these efforts. Additionally, they are responsible to assist the program manager is setting up speaking engagements and public awareness events. This committee meets on the 2nd Wednesday of each month except December at 8:30 a.m. in the EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.

Partnership and Volunteer Development Committee, Holly Morgan-Frye, Chair

Risk Assessment and Mitigation Planning Committee, Mason Carter, Chair

Any interested person may serve on this committee. The Risk Assessment/Mitigation Planning Committee will examine the community's risks and vulnerability to all hazards and assess the community's vulnerability to those risks. Additionally, they will look at specific buildings, infrastructure, etc. to determine which are most susceptible to risks. A Risk Assessment and Mitigation Plan was completed and adopted by the Jefferson County Commission, all Jefferson County municipalities, WVOHSEM, and Federal Emergency Management Agency in July, 2003. Counter Terrorism Committee, Barbara Miller, Director, Chair

Membership to this sub-committee of the Risk Assessment and Mitigation Planning Committee is limited to members of law enforcement, emergency management, homeland security, emergency communications, Red Cross, schools, health care, fire companies, ambulance authority/EMS, and government, due to sensitive homeland security issues. The committee works on issues of planning and training for counter terrorism or human-caused disasters.
