# JCHSEM Receives \$13,000 Whole of Community Grant from Volunteer WV!

Charles Town- The Jefferson County Commission and Jefferson County Homeland Security and Emergency Management has received a \$13,000 "Whole of Community" DHS/Citizen Corps Grant through Volunteer WV!. This grant will enable JCHSEM to hold a luncheon to honor and recognize current volunteers for their service to our organization and to increase business partnerships; purchase a subscription to a web-based volunteer management system; purchase supplies for Fire Safety Month activities; pay for booth space and volunteers' tickets at the Jefferson County Fair; purchase items to attract people to our booth; sustain our C.E.R.T. program by paying for copies of new C.E.R.T. participation and instructor manuals; and purchase of National Preparedness Month supplies. The outreach activities serve to help us recruit additional partners and volunteers and to teach residents about the risks we face in Jefferson County.

The Whole of Community approach to Emergency Management is being promoted by the U.S. Department of Homeland Security (DHS) and the Federal Emergency Management Agency (FEMA). Instead of depending completely on government-centric emergency management, DHS and FEMA want emergency managers to reach out to the whole community, including private businesses, non-governmental organizations, volunteer agencies, faith-based organizations, etc. to involve them in planning for, protecting against, responding to, and recovering from all types of disasters.

"This grant enables us to encourage new business partner relationships and the opportunity to bring in some organizations that have not been involved with our organization in the past," said Barbara Miller, JCHSEM director. "The Whole of Community Concept is starting to crop up as a requirement for most of the federal and state grants and projects. In Jefferson County, we have been formally building partnerships such as these since 2002 when we were named as a FEMA Project Impact Community. We are very fortunate to live in a community that is extremely involved in sustainable partnerships, has well-trained volunteers, and readily shares resources within the region. Involving the Whole Community means taking care of the Whole Community; leveraging assets across the Whole Community, building resilience and resistance to future disasters across the Whole Community. "Whole of Community" is you, me, and everyone in our community taking a responsibility and a role in planning, protecting, mitigating, and recovering from incidents, man-made or natural. Too often, we have tried to stay within our own boxes, our own budgets, and our own planning. But especially during tough budgetary and economic times, when none of us has all of the assets to do everything ourselves, we need to admit limitations and reach out to partners in the private, public and voluntary sectors for support, expertise and resources."

The grant period runs through December 9, 2011 and activities have already begun.

# SCENES FROM THE DEMONSTRATIONS



Huntington, WV– Marshall University was the venue for the U.S. Senator Rockefeller and the Discover the Real West Virginia Foundation, Inc.'s 2011 Homeland Security Summit. This was the Senator's 4th Conference.

Day one included demonstrations by the Cabell County Mobile Command Center and License Plate Reader, WV Office of Miners' Health Safety and Training-Mobile Unit, WV Department of Homeland Security and Emergency Management's Mobile Operations Center and Portable Radio, WV National Guard Joint Incident Site Communications Kit; Memorial Tunnel Training Stream; Civil Support Team equipment on display; and the HH60 Blackhawk helicopter, Wood County's Mobile Command Unit, WV State Police demonstration and exhibits, Air Robotics-Unmanned Aerial Vehicle, U.S. Coast Guard Boat and Trailer, STS International, and WV Department of Environmental Protection. All demonstrations were held at the Marshall University Football Stadium Parking Lot.

The evening featured dinner at the Don Morris Room/Memorial Student Center, where Tom Heywood, Managing Partner of Bowles, Rice, McDavid, Graff & Love, LLP and President of the Real West Virginia Foundation, Inc. gave opening remarks followed by Major General James A. Hoyer led the pledge of allegiance. Video remarks were shown from The Honorable Nick J. Rahall, U.S. Congress. Further remarks were heard from U.S. Senator John D. Rockefeller, IV and Dr. Stephen Kopp, President of Marshall University.

The highlight of the conference was the keynote address by The Honorable Janet Napolitano,

Secretary of U.S. Department of Homeland Security.

The next day's opening plenary session was: The 10 year anniversary of 9-11: Where are we now? G110, Emergency Management Operations Course (EMOC) for Local Governments

24 Hours

Instructors: Larry Allen/Jeff Harvey

The EMOC is an exercise-based program with planning sessions that begin weeks prior to the actual course, and it includes classroom sessions and exercises. The purpose of the EMOC is to improve operational capabilities as they relate to managing emergencies in the local community. The course places emphasis on the Emergency Operations Center as the focal point for managing a simulated emergency. Selection Criteria: Elected and appointed city and county officials. These include mayor, city manager, city council, county commissioner, county manager, and other key positions, such as emergency management director and public information officer. Also included as eligible participants, are upper and midmanagement personnel, including supervisory, operational, and communications staff from the fire service, law enforcement, public works, and emergency medical services. Volunteer groups should also participate.

G775, Emergency Operations Center (EOC) Management and Operations

Instructors: Dave Bradley/Larry Allen

This course explores the role, design, and functions of the EOC and their relationships as components of a multiagency coordination system. The course contains disaster-related examples, activities, and case studies that relate to EOCs and multiagency coordination systems at the local, State, and Federal levels of government. Selection Criteria: This course is open to all Federal, State, local, Tribal emergency managers; first responders to include incident commanders from all emergency management disciplines; private industry personnel responsible for coordination activities during a disaster; and Voluntary Organizations Active in Disaster (VOAD).

17 Hours

Instructor: Carla McBee

This course prepares local and State response personnel and other responsible agencies and professionals to handle mass facilities and effectively and to work with the survivors in an emergency or disaster. This course covers incident management, mass fatalities, planning before and operations during an incident, establishing the morgue, family assistance from the Federal government. The course concludes with a tabletop exercise.

### Jefferson County Homeland Security and Emergency Management-Committees

### Steering Committee, John Sherwood, Chair

The Steering Committee works with the JCHSEM Director to guide the activities of JCHSEM. A fourteen-member Steering Committee is made up of public and private representation. JCHSEM is a Department within the Jefferson County Commission, who has overall responsibility for the department and its employees. The Jefferson County Commission appoints all members to the steering committee. This committee meets on the 4<sup>th</sup> Tuesday of each month at 9:00 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.

### Animals in Disaster Committee, Kelly Parsons, Chair

Any interested person can serve on this committee. The Animals in Disaster Committee is responsible for developing and updating the Animals in Disaster Plan and to work with the JCHSEM to make recommendations regarding the Animals Annex of the Emergency Operations Plan. They will also identify potential resources for animals before, during and after a disaster. The committee meets on the 3<sup>rd</sup> Monday of the months of January, April, July, October at 9:30 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.

### Emergency Planning for People with Special Needs Committee-Chair - Pamela Holstein-Wallace, Chair

Any interested person can serve on this committee. The Emergency Planning for People with Special Needs Committee is responsible for training and planning for issues of people who have mobility problems, people who have sight or hearing problems, people who speak a language other than English as their first language, the elderly and the very young, people who use oxygen or other medical devices and anyone who may need special assistance during times of disasters and/or evacuations. This committee will work with the JCOHSEM to update the portion of the Emergency Operations Plan that deals with these special needs. This committee meets on the 3<sup>rd</sup> Monday of the months of March, June, September, and December at 9:30 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced. This room IS handicapped accessible.

### Public Awareness, Education and Training Committee, Katherine Dunbar, Chair

Any interested person can serve on this committee. The Public Awareness, Education and Training Committee is responsible to communicate the organization's activities to the public and to build support for JCHSEM's programs. They work with the Director and other staff to keep the entire community focused on the objectives of JCHSEM, the opportunities for additional involvement and support by updating citizens and businesses about what the partners are doing and how the community will and is benefiting from these efforts. Additionally, they are responsible to assist the program manager is setting up speaking engagements and public awareness events. This committee meets on the 2<sup>nd</sup> Wednesday of each month except December at 8:30 a.m. in the EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.

### Partnership and Volunteer Development Committee, Holly Morgan-Frye, Chair

Any interested person can serve on this committee. The Partnership Development committee assists the staff in identification and recruitment of potential partners and what they have to offer in community preparedness. This committee will be responsible for activities to promote partnership or membership development and recruitment of volunteers. This committee meets quarterly in the EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced. at 9:30 a.m. on the last Monday of January, April, July and October.

### Risk Assessment and Mitigation Planning Committee, Mason Carter, Chair

Any interested person may serve on this committee. The Risk Assessment/Mitigation Planning Committee will examine the community's risks and vulnerability to all hazards and assess the community's vulnerability to those risks. Additionally, they will look at specific buildings, infrastructure, etc. to determine which are most susceptible to risks. A Risk Assessment and Mitigation Plan was completed and adopted by the Jefferson County Commission, all Jefferson County municipalities, WVOHSEM, and Federal Emergency Management Agency in July, 2003. The committee currently updated the original document. This committee meets on an "as needed basis". Please call the office at 728-3329 for exact dates and times.

### Counter Terrorism Committee, Barbara Miller, Director, Chair

Membership to this sub-committee of the Risk Assessment and Mitigation Planning Committee is limited to members of law enforcement, emergency management, homeland security, emergency communications, Red Cross, schools, health care, fire companies, ambulance authority/EMS, and government, due to sensitive homeland security issues. The committee works on issues of planning and training for counter terrorism or human-caused disasters. Meetings are held on the 2<sup>nd</sup> Tuesday of the month at the EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.
