EXERCISES COMING UP

WV Dept. of Agriculture will conduct a Multi-County Avian Flu Response Program on January 12, 2012 from 9 a.m.—3:30 p.m. at the Moorefield Fire Department Bingo Hall at 114 Kuykendall Lane in Moorefield. Jefferson Memorial Hospital will be holding an internal drill on January 13, 2012. The Jefferson County EOC will be used as their SIMCELL.

Jefferson County Government will be holding a COOP Training on February 17, 2012 followed by a Tabletop Exercise on February 29th. This is for the department that are in the County's COOP. Further information to follow.

Jefferson County LEPC will be holding a Tabletop Exercise at the completion of their Commodity Flow Study. Further details as they bring their consultant onboard.

The seven counties of the Eastern Panhandle are working with the EPA on a full scale exercise in the late summer/early fall. Details will be released by the planning committee as they become available.

Holiday Fire Safety

With winter holidays coming up, one of the best gifts you can give your family is a safe home in which to celebrate the season!

Pick a "safe" tree. If you're buying a cut tree for Christmas, check for freshness. A fresh tree has a good green color and needles that are hard to pull from the branches and do not break. Shedding, brittle needles and a faded green color are signs of a dry tree. Keep your tree fresh by placing it in a stand that holds water. Check the water level every day.

Choose "fire resistant"-labeled artificial trees and decorations. This does NOT mean these items won't catch fire—it does mean that they should resist burning and extinguish fairly quickly in the even of fire.

Pick a safe place for your tree. Keep your tree out of traffic areas and away from doorways—exits should always be clear. Also, make sure there's a "safety zone" all around your tree—at least 3 feet away from fireplaces, wood stoves and other heat sources (candles included).

Don't overload circuits. With the extra lights and holiday decorations, don't be tempted to plug too many items into your outlets. Unplug items that aren't in use, and never ignore a tripped fuse.

Before those lights go up: Check each set of lights, new or old, for broken or cracked sockets, frayed or bare wires, or loos connections. Don't forget to check your extension cords, too. Throw out any damaged lights or cords.

Whether indoor or outdoor lights, use only lights that have been UL-approved. If the lights you're using haven't been tested by Underwriters' Laboratories or another national testing lab, you run a very real risk of fire—your lights haven't been manufactured in accordance with recognized safety standards.

Never run extension cords through doorways, under rugs, or through any high-traffic areas. This can damage the insulation and wire inside, causing a fire hazard.

Always disconnect all decorative lights before you go to bed or leave the house. Lights can short out and cause a fire.

Don't hang light strings in any way that might damage the cord's insulation. Never use nails or tacks. Use only insulated staples to hold strands in place, or run the strings through hooks.

Be careful with candles! Always display candles safely by keeping them in stable, non-flammable holders. Keep them away from things that will burn, such as other decorations or curtains—away from children and pets.

Fireplace safety: Never burn gift wrappings. Flash fires can occur when gift wrap suddenly bursts into flame and burns intensely. Burning papers and other improper fuels in the fireplace is a major cause of chimney fires. Always use a fire screen to keep sparks from escaping onto nearby rugs, upholstered furniture or other combustibles.

Be extra careful when smoking. Careless smoking is a leading cause of fire deaths at any time of the year, but the risk goes up during holiday gatherings. Check carefully for any smoldering smoking materials (between cushions, under furniture, etc.) before going to bed. Never smoke around the tree or flammable decorations.

Working smoke alarms save lives. Winter—and holidays—can bring increased risk of fire. If you haven't changed the batteries in your smoke and carbon monoxide alarms this year, now is a good time. Your family might have only minutes to escape a fire.

Regional Animals Annex Finalized

The Emergency Managers in the seven counties of the Eastern Panhandle have finalized their work with J.H. Consulting on their new Regional Animals Annex for their respective Emergency Operations Plans. The plan contains a basic plan, specific information on particular types of companion animals, and certain livestock; a listing of possible resources throughout WV Homeland Security Region 3, samples of public information, forms and templates that may be needed for large disasters involving animals and same MOUs; an appendix with a GAP analysis of continued planning and efforts that still need to be done for implementation of the plan; and a glossary of terms and acronyms used in the plan. The plan is currently being reviewed by WV Department of Military Affairs and Public Safety. Once it is approved by WVDMAPS it will be ready to be adopted by the respective county commissions in each county.

Jefferson County Homeland Security and Emergency Management to Receive a \$30,000 Homeland Security Grant for a Rapid Response Companion Animal Sheltering Trailer and Supplies

JCHSEM has been notified that they have been chosen as a recipient of a \$30,000 Homeland Security Grant to purchase a Rapid Response Companion Animal Sheltering Trailer and Supplies. "I submitted the Project Concept for this project after the Regional Animals Annex that we just completed identified that there was no such resource anywhere in the Eastern Panhandle. If we needed this resource, the closest response would have been approximately 3 hours away. This need was also recently identified in one of our exercise After Action Reports. We are very appreciative to the committee that chose the recipients for the Mass Care Grant Project," said Barbara Miller, Jefferson County's Emergency Manager. "This will enable our county, as well as, this region of West Virginia to comply with the PETS ACT (Pets Evacuation and Transportation Standards Act of 2005). The approval of this grant is on the County Commission's agenda on January 5, 2012. There are no required local matching funds for the project. The project period is February-October, 2012.

Joint Meeting of the Jefferson And Berkeley County LEPCs.

There will be a combined meeting of the Jefferson and Berkeley **County Local Emergen**cy Planning Committees on Monday, December 12 at 2:30 p.m. in the **Berkeley County EOC.** The purpose of the meeting is to meet with Don McLaughlin of the Environmental Protection Agency. The EPA is going to assist the Counties of the Eastern Panhandle with developing, carrving out and documenting a Regional Full Scale Exercise next Spring. Additionally, this meeting will provide an opportunity for members of the two LEPCs to network and get to know each other and each County's intricacies. Lite refreshments will be served. All members from both county's LEPCs are strongly encouraged to attend this meeting. Agencies that have specific things that they would like to test during the functional exercise should contact their respective Emergency Manager with details. This can include new plans, protocols or SOGs, new pieces of equipment, etc.

Steering Committee, John Sherwood, Chair

The Steering Committee works with the JCHSEM Director to guide the activities of JCHSEM. A fourteen-member Steering Committee is made up of public and private representation. JCHSEM is a Department within the Jefferson County Commission, who has overall responsibility for the department and its employees. The Jefferson County Commission appoints all members to the steering committee. This committee meets on the 4th Tuesday of each month at 9:00 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.

Animals in Disaster Committee, Kelly Parsons, Chair

Any interested person can serve on this committee. The Animals in Disaster Committee is responsible for developing and updating the Animals in Disaster Plan and to work with the JCHSEM to make recommendations regarding the Animals Annex of the Emergency Operations Plan. They will also identify potential resources for animals before, during and after a disaster. The committee meets on the 3rd Monday of the months of January, April, July, October at 9:30 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.

Emergency Planning for People with Special Needs Committee-Chair -, Chair

Any interested person can serve on this committee. The Emergency Planning for People with Special Needs Committee is responsible for training and planning for issues of people who have mobility problems, people who have sight or hearing problems, people who speak a language other than English as their first language, the elderly and the very young, people who use oxygen or other medical devices and anyone who may need special assistance during times of disasters and/or evacuations. This committee will work with the JCOHSEM to update the portion of the Emergency Operations Plan that deals with these special needs. This committee meets on the 3rd Monday of the months of March, June, September, and December at 9:30 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced. This room IS handicapped accessible.

Public Awareness, Education and Training Committee, Katherine Dunbar, Chair

Any interested person can serve on this committee. The Public Awareness, Education and Training Committee is responsible to communicate the organization's activities to the public and to build support for JCHSEM's programs. They work with the Director and other staff to keep the entire community focused on the objectives of JCHSEM, the opportunities for additional involvement and support by updating citizens and businesses about what the partners are doing and how the community will and is benefiting from these efforts. Additionally, they are responsible to assist the program manager is setting up speaking engagements and public awareness events. This committee meets on the 2nd Wednesday of each month except December at 8:30 a.m. in the EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.

Partnership and Volunteer Development Committee, Holly Morgan-Frye, Chair

Any interested person can serve on this committee. The Partnership Development committee assists the staff in identification and recruitment of potential partners and what they have to offer in community preparedness. This committee will be responsible for activities to promote partnership or membership development and recruitment of volunteers. This committee meets quarterly in the EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced. at 9:30 a.m. on the last Monday of January, April, July and October.

Risk Assessment and Mitigation Planning Committee, Mason Carter, Chair

Any interested person may serve on this committee. The Risk Assessment/Mitigation Planning Committee will examine the community's risks and vulnerability to all hazards and assess the community's vulnerability to those risks. Additionally, they will look at specific buildings, infrastructure, etc. to determine which are most susceptible to risks. A Risk Assessment and Mitigation Plan was completed and adopted by the Jefferson County Commission, all Jefferson County municipalities, WVOHSEM, and Federal Emergency Management Agency in July, 2003. The committee currently updated the original document. This committee meets on an "as needed basis". Please call the office at 728-3329 for exact dates and times.

Counter Terrorism Committee, Barbara Miller, Director, Chair

Membership to this sub-committee of the Risk Assessment and Mitigation Planning Committee is limited to members of law enforcement, emergency management, homeland security, emergency communications, Red Cross, schools, health care, fire companies, ambulance authority/EMS, and government, due to sensitive homeland security issues. The committee works on issues of planning and training for counter terrorism or human-caused disasters. Meetings are held on the 2nd Tuesday of the month at the EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.
