Every Business Should Have A Plan. Business Continuity Planning Workshop

Jefferson County Homeland Security and Emergency Management is sponsoring two Business Continuity Planning Workshops to be held on September 23, as a part of their National Preparedness Month Activities. There are two workshops to choose from. You may register for the afternoon class from 1:00-4:00 p.m. or the evening class from 6:00-9:00 p.m. Both classes are being taught by the WV Department of Military Affairs and Public Safety's Continuity Program Manager, Matt Blackwood, with assistance from David Skeen, WV Department of Homeland Security and Emergency Management. Both classes are being taught at the Jefferson County Maintenance Department's Meeting Room, 128 Industrial Blvd., Kearneysville, WV 25430. You must pre-register to attend.

Whether you own a small business or a large one, work for a non-profit group or are a part of a government agency, you need to have a BCP (Business Continuity Plan).

How quickly your company can get back to business after a tornado, a public health emergency, a fire or flood often depends on emergency planning done before the event happens. Business fires, cyber attacks, and wind damages demonstrate the importance of being prepared. When you also consider that the number of declared major disasters nearly doubled in the 1990's compared to the previous decade, preparedness becomes an even more critical issue. Though each situation is unique, any organization can be better prepared if it plans carefully, puts emergency procedures in place, and practices for all kinds of emergencies. If businesses are ready to survive and recover, the nation and our economy are more secure. America's businesses form the backbone of the nation's economy; small businesses alone account for more than 99% of all companies with employees, employ 50% of all private sector workers and provide nearly 45% of the nation's payroll. A commitment to planning today will help support employees, customers, the community, the local economy and even the country. It also protects your business investment and gives your company a better chance for survival. Business continuity planning outlines commonsense measures business owners and managers can take to start getting ready. It provides practical information to help you plan for your company s future. These recommendations reflect the Emergency Preparedness and Business Continuity Standard (NFPA 1600) developed by the National Fire Protection Association and endorsed by the America National Standards Institute and the U.S. Department of Homeland Security. L-146 Homeland Security Exercise and Training Course (HSEEP) to be taught in Kearneysville on Oct. 7/8

The L-146 Homeland Security Exercise and Training Course (HSEEP) will be taught on October 7/8 at the Jefferson County Maintenance Department Meeting Room from 0800-1700 daily. Lunch will be provided. This course will be taught by Greg Fuller and Jerry Beckett for WV Division of Homeland Security and Emergency Management.

The two-day period of instruction is for those individuals that are directly involved in the planning, design and evaluation of training exercises. The intermediate-level training course incorporates exercise guidance and best practices from the HSEEP Volumes. It is an interactive course that allows participants to share personal lessons learned and best practices while gaining practical experience. In addition to the instructor-led course presentations, the course includes small group activities; group discussions; introductions to HSEEP; related initiatives such as supporting technology; and capabilities-based planning. This approach provides participants with hands-on experience that readily translates to real-world exercise responsibilities. Activities include creating exercise documentation, conducting planning conferences and briefings, and practicing exercise evaluation.



The Steering Committee works with the JCHSEM Director to guide the activities of JCHSEM. A fourteen-member Steering Committee is made up of public and private representation. JCHSEM is a Department within the Jefferson County Commission, who has overall responsibility for the department and its employees. The Jefferson County Commission appoints all members to the steering committee. This committee meets on the 4th Tuesday of February. March, May, June, August, September and holds a Nov/Dec meeting at 9:00 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced. The Quarterly Partnership meetings held in January, April, July, and October also serve as the Steering Committee meetings for those months.

Public Awareness, Education and Training Committee, Katherine Dunbar, Chair

Any interested person can serve on this committee. The Public Awareness, Education and Training Committee is responsible to communicate the organization's activities to the public and to build support for JCHSEM's programs. They work with the Director and other staff to keep the entire community focused on the objectives of JCHSEM, the opportunities for additional involvement and support by updating citizens and businesses about what the partners are doing and how the community will and is benefiting from these efforts. Additionally, they are responsible to assist the program manager is setting up speaking engagements and public awareness events. The Risk Assessment/Mitigation Planning Committee examine the community's risks and vulnerability to all hazards and assess the community's vulnerability to those risks. A Risk Assessment and Mitigation Plan was completed and adopted by the Jefferson County Commission, all Jefferson County municipalities, WVHSEM, and Federal Emergency Management Agency in July, 2003. The plan was updated in 2008 and 2013. The 2013 Plan was approved by WVDHSEM and FEMA in June, 2013. This committee meets Quarterly. Please call the office for exact dates and times.

Counter Terrorism Committee, Barbara Miller, Director, Chair

Membership to this sub-committee of the Risk Assessment and Mitigation Planning Committee is limited to members of law enforcement, emergency management, homeland security, emergency communications, Red Cross, schools, health care, fire companies, ambulance authority/EMS, and government, due to sensitive homeland security issues. The committee works on issues of planning and training for counter terrorism or human-caused disasters.
