Take time now to think about how you will handle the next disaster...before, during and after

2014 has already brought fires, floods, polar vortexes, extreme cold, snow, and chemical spills to our state. So while we are between storms, please take a few minutes to think about what you will do when, "it will never happen to me" happens. Next up...spring floods, thunderstorm/tornado season!

Take 30 minutes to plan, and think in terms of: Water, Food, Prescriptions, Pets, Communications, Fuel, Finances, and Insurance.

Some recommendations:

At least a 3-day supply of

- ◆ bottled water—1 gallon per day, per family members, extra for people with special needs, babies, and/or pets.
- ◆ nonperishable foods.
- ◆ Prescription medications (follow your pharmacy's advice on storage).
- ◆ Food and water for your pets.
- ◆ Cash
- ◆ Keep your cell phone and mobile devices charged. Remember you can charge them in your car if your power is out. Also keep a flashlight with fresh batteries and a battery-operated radio available.
- ◆ Never let your vehicle get below half of a tank of gasoline.
- ◆ Make sure you have adequate insurance on your home—homeowners or renters insurance, flood insurance (floods are not covered in a regular policy), and contents. Also make sure you have smoke alarms that are maintained and tested regularly.

JCHSEM Receives Grant to Replace EOC Laptop Computers

JCHSEM was recently awarded a \$50,000 grant from the West Virginia State Administrative Agency/U.S. Department of Homeland Security to replace 20 laptop computers that are needed in the Emergency Operations Center. These computers are used by those who serve in the Emergency Support Function positions in the EOC during activations, including those who do reporting on WEBEOC and E-Team, keep the log of activities, watch the weather, send out news releases, and monitor and send information through social media. They will also be used by members of the military who serve in the EOC in the positions of LNOs (Liaison Negotiating Officers), who usually have reporting requirements that require a computer to perform. “The old computers are at the end of their useful life,” said Barbara Miller, Director of Homeland Security and Emergency Management for Jefferson County. “The replacement of these computers will increase the capabilities of those who serve in the EOC to perform their primary functions of coordination of information and resources throughout incidents and emergencies. These computers will also allow us to utilize the County’s new CAD system. Additionally, they will be used for training and disaster exercises. We appreciate the continued support of the state and federal government to assist us to do our jobs most effectively. We expect to take delivery of the new laptops in April.”

JCHSEM’s Disaster Ready Kids Program Receives Grant from Citizen Corps

The purchase of new DVDs, books, and supplies is being made possible through a grant of \$2,800 from the West Virginia Citizen Corps program/WV State Administrative Agency/U.S. Department of Homeland Security. “This grant will enable us to update some of the educational materials that we use for our Disaster Ready Kids Program for 2014 and beyond,” said Barbara Miller, Director of Homeland Security and Emergency Management in Jefferson County. “This program runs from May through September each year and we have educational materials for children from ages 3-12. Our staff and volunteers deliver programs to daycare centers, elementary schools, groups that are home schooled, 4-H groups, church camps, scouts, and others throughout the summer months to teach age-appropriate information about natural hazards such as floods, tornadoes, power outages, and thunderstorms. This material teaches children to not be afraid and how to work with their families to prepare for storms. Each child then takes home a “parent packet” so that their family can also learn preparedness techniques.” Jefferson County has been a part of the West Virginia Citizen Corps program since 2002. The purchase of the new materials will occur during the months of April and May.

Jefferson County to Participate in Virtual Tabletop Exercise- Flood Focus with FEMA on March 19

Jefferson County will participate in FEMA's Virtual Tabletop Exercise-Flood Focus in March.. FEMA has assigned Jefferson County the date of March 19 from noon—4 p.m. The exercise will be conducted using Video-Teleconference Technology (VTC), and is intended to provide an opportunity for responders across the Nation to simultaneously participate in a hazard-specific facilitated discussion. Lead facilitation for the exercise will be coordinated by FEMA's Emergency Management Institute, with local facilitation provided by Patricia Davis, JCHSEM Volunteer. This format will allow the common delivery of exercise materials, scenarios, modules, and discussion questions among those participating in the exercise. The After Action Report/Improvement Plan will be completed by the local jurisdiction and must be submitted to FEMA within 30 days of the Table Top Exercise.

The virtual exercise will enable the participants to exercise their knowledge, skills, and abilities needed to effectively conduct all-hazards emergency preparedness, response, and recovery. Overall, the goals will include:

- ◆ Prepare participants for a flood scenario affecting their community.
- ◆ Enable participants to better coordinate their response operations with counterparts from local governments, other State governments, Federal agencies, private sector organizations, and non-governmental agencies.
- ◆ Leverage VTC Technology to reach remote sites.
- ◆ Provide a virtual, experiential education environment to exercise and enhance critical response and recovery tasks.

Who should attend: The VTTX program is designed for a “community based” group of personnel from local or state emergency management organizations with representation from all Emergency Management disciplines—Emergency Management, Emergency Communications, Fire, EMS, Law Enforcement, Public Works, Public Health, Health Care, Government, Administrative, Military, Private Sector, and Non-Governmental organizations. This exercise is not suited for individuals, but rather representatives from the above organizations.

Exercise Design: This VTTX is designed to engage the participants in a no fault, hazard-specific exercise discussion. The lead facilitation will occur via VTC from the EMI campus, and will be complimented by a dedicated local agency facilitator on-site. The VTTX will be supported by an Exercise and Coordination Facilitation Guide, which will include all required logistical information (room layout, connection instructions, etc.), as well as facilitation and hot wash instructions.

- ◆ The VTTX will consist of:
- ◆ A Hazard Awareness briefing on the scenario hazard.
- ◆ Three discussion modules presented by the EMI facilitator
- ◆ Local discussion with guided questions facilitated by an on-site facilitator
- ◆ Brief outs from each participating location after each module.
- ◆ Hot wash conducted at each location after the VTC has ended
- ◆ AAR/IP submission by the participating organization no later than 30 days from the completion of the VTTX event.

Once the final details are received from FEMA, an invitation will go out to the agencies listed above to participate. Volunteering as an exercise evaluator will be Michael Wolfe, Director of Monongalia Homeland Security and Emergency Management and Vice Chair of the WV Emergency Management Council.

Steering Committee, John Sherwood, Chair

The Steering Committee works with the JCHSEM Director to guide the activities of JCHSEM. A fourteen-member Steering Committee is made up of public and private representation. JCHSEM is a Department within the Jefferson County Commission, who has overall responsibility for the department and its employees. The Jefferson County Commission appoints all members to the steering committee. This committee meets on the 4th Tuesday of February, March, May, June, August, September and holds a Nov/Dec meeting at 9:00 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced. The Quarterly Partnership meetings held in January, April, July, and October also serve as the Steering Committee meetings for those months.

Public Awareness, Education and Training Committee, Kelly Parsons, Chair

Any interested person can serve on this committee. The Public Awareness, Education and Training Committee is responsible to communicate the organization's activities to the public and to build support for JCHSEM's programs. They work with the Director and other staff to keep the entire community focused on the objectives of JCHSEM, the opportunities for additional involvement and support by updating citizens and businesses about what the partners are doing and how the community will and is benefiting from these efforts. Additionally, they are responsible to assist the program manager in setting up speaking engagements and public awareness events. Risk Assessment and Mitigation Planning Committee, Jeff Jefferies, Chair

The Risk Assessment/Mitigation Planning Committee examines the community's risks and vulnerability to all hazards and assess the community's vulnerability to those risks. A Risk Assessment and Mitigation Plan was completed and adopted by the Jefferson County Commission, all Jefferson County municipalities, WVHSEM, and Federal Emergency Management Agency in July, 2003.
