

Coronavirus Update

On Friday, August 14, 2020, Governor Jim Justice unveiled the "School Re-entry Metric and Protocols" map. The School Re-entry Metric and Protocols – developed by Governor Justice, the West Virginia Department of Health and Human Resources (WV DHHR), and the West Virginia Department of Education (WVDE) – provide a consistent tool that will assess community transmission. The color-coded system, known as the School Alert System, is driven by data and science to monitor the level of COVID-19 in each county. The system is based on each county's number of new daily cases per 100,000 people on a seven-day rolling average. This figure will be calculated and updated by the WV DHHR. Based on that figure, each county was initially assigned one of four colors – green, yellow, orange, or red – which is meant to represent the severity of the rate of community spread. Since starting, another color, GOLD, was added.

The map is updated daily for informational purposes. However, each county's officially designated status will be determined on a weekly basis. Each Saturday, each county receives an official color status that will remain in place through the following Saturday evening.

Once the spread of COVID-19 reaches identified levels, counties must respond with specific mitigation actions to prevent further spread.

All counties identified as green and yellow on the Saturday prior to the scheduled first day of school, may begin in-person instruction and will be permitted to do so as long as levels remain steady.

Counties with orange or red levels will not be permitted to begin in-person instruction until yellow or green levels are reached on a seven-day rolling basis. Schools in orange or red counties will be full remote learning until yellow or green levels are achieved.

After opening, if a county elevates to orange in its official Saturday status, it may continue to operate in-person instruction under the orange school re-entry protocols. Athletics and extracurricular activities would be limited to controlled practices/activities only and no competitions would be permitted. However, if a county were to reach orange levels in the middle of the week, athletics and extracurricular activities would be permitted to continue until the county reaches orange levels in its official Saturday status.

If a county elevates to red at any time, regardless of the day of the week, all in-person instruction, athletics, and extracurricular activities will be halted the next regularly scheduled school day, and will not resume until the county's levels return to green or yellow. In this scenario, schools in red counties will be full remote learning until yellow or green levels are achieved.

All of West Virginia's private and Christian schools will be subject to the same color scale as public schools. In the event of an outbreak within a contained location, such as a correctional facility, nursing home, etc., the outbreak would count as one positive incidence of COVID-19 among inmates/residents, while the number of positive staff members will be counted at 50 percent before being added to the total case number that will be used in determining each county's metric.

The School Re-entry Metric and Protocols will be in effect so long as the state, as a whole, remains below a 5 percent positivity rate based on a rolling, seven-day average.

On Tuesday, September 15, 2020, Governor Justice announced the addition of a new color, GOLD, to the School Alert System. Counties in gold have 10.0–14.9 cases of COVID-19 infection per 100,000 people. Up until that time, counties with these numbers were categorized as orange. However, in an emergency meeting Governor Justice and state health experts determined that the orange category was too broad.

The updated thresholds are as follows: **GREEN:** 3 and fewer cases per 100,000 OR 3% or less positivity rate **YELLOW:** 3.1 - 9.9 cases per 100,000 OR 4% or less positivity rate **GOLD:** 10 - 14.9 cases per 100,000 OR 5% or less positivity rate **ORANGE:** 15 - 24.9 cases per 100,000 **RED:** 25+ cases per 100,000

In the gold category, counties will be able to move to an in-person instructional model with restrictions including face coverings at all times for grades 3-12. Extracurricular activities are permitted and competitions may occur against schools within the same county as well as schools in other gold counties. Additionally, modifications to spectator requirements at extracurricular activities have been made.

 - Discuss what you learned and make improvements.



Disaster Exercise Series 2020

Online FEMA Training

FEMA offers a number of online courses at <u>https://training.fema.gov/emi.aspx</u>. From this training portal, anyone can take their online independent study courses for free. There are over 100 courses to choose from. You can also browse the schedules and information about their on-campus resident courses for those who are involved in emergency management in the federal, state, local or tribal governments.

JCOHSEM recommends the following FEMA Independent Study Courses. These courses are free and available online. After the course is completed an online test can be taken. Once the test is passed you will receive a completion certificate.

IS-366.A: Planning for the Needs of Children in Disasters

Course Description: The purpose of this course is to provide guidance for emergency managers and implementers of childrens' programs about meeting the unique needs that arise among children as a result of a disaster or emergency. Much of the information in this course is based upon a document titled "The Unique Needs of Children in Emergencies: A Guide for the Inclusion of Children in Emergency Operations Plans," published by Save the Children.

Primary Audience: The target audience for this course is local and state emergency managers and planners. Other individuals or groups that may benefit from taking this course include those directly involved with meeting the needs of children, such as the following: judges and other members of the state, county, and local governmental legal system, Voluntary Organizations Active in Disasters (VOADs), faith-based organizations, and other non-profits, child service agencies, child care providers, and schools.

Course Length: Approximately 6 hours

IS 522 - Exercising Continuity Plans for Pandemics

Course Description: This course is based on the pandemic continuity tabletop exercise Determined Accord. The course covers fundamental continuity principles and processes but is focused on the special continuity requirements for pandemics. Strategies such as telework and other social distancing strategies are described, as well, as special protection strategies for first responders, healthcare personnel, and others who have daily contact with the public.

Primary Audience: At the conclusion of this course, the students should be able to: relate the anticipated conditions and effects of a pandemic influenza to responders and communities, describe best practices for planning for and responding to a pandemic influenza, apply knowledge of the anticipated conditions and suggested practices to an activity, and develop next steps for pandemic planning within their agencies or communities.

Course Length: Approximately 8 hours

IS 909 - Community Preparedness: Implementing Simple Activities for Everyone

Course Description: Community members are the key to our nation's preparedness and resilience. The purpose of this course is to present a model program for community preparedness. In addition, resource materials are available to help organizations conduct simple preparedness activities for everyone. By the end of this course, participants will be able to identify the definition of preparedness, describe the role of individual and household preparedness, and describe the purpose of community based preparedness activities. **Primary Audience:** The primary audience for this course is the whole community including emergency management personnel and representatives of faith-based and nonprofit organizations.

Public Awareness, Education and Training Committee, Paula Marrone-Reese, Chair

Any interested person can serve on this committee. The Public Awareness, Education and Training Committee is responsible to communicate the organization's activities to the public and to build support for JCOHSEM's programs. They work with the director and other staff to keep the entire community focused on the objectives of JCOHSEM, the opportunities for additional involvement and support by updating citizens and businesses about what the partners are doing and how the community will and is benefiting from these efforts. This committee is responsible in assisting the director in setting up speaking engagements and public awareness events. All Hazards Mitigation Planning Committee, Mason Carter, Chair

Any interested person may serve on this committee. The All Hazards Mitigation Planning Committee examines the community's risks and vulnerability to all hazards and assess the community's vulnerability to those risks. An All Hazards Mitigation Plan was completed and adopted by the Jefferson County Commission, all Jefferson County municipalities, West Virginia Emergency Management Division of the West Virginia Department of Homeland Security (WVEMD) and FEMA in July 2003. The plan was updated in 2008 and 2013. The 2013 plan was approved by WVEMD and FEMA in June 2013 and the 2018 plan was approved in November 2018.

Counter Terrorism Committee, Stephen Allen, Chair

Membership to this sub-committee of the Risk Assessment and Mitigation Planning Committee is limited to members of law enforcement, emergency management, homeland security, emergency communications, Red Cross, schools, health care, fire companies, ambulance authority/EMS, and government, due to sensitive homeland security issues. The committee works on issues of planning and training for counterterrorism or human-caused disasters. Meetings are held on the second Tuesday of the month at the EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.
