## THE FINE PRINT

- 1) If you register for this course and fail to show, you may not be allowed to attend future courses at Jefferson County Emergency Services Agency.
- 2) If the course is a Hybrid course and you utilize the code that is emailed to you AND FAIL TO ATTEND the in-person portion of the course, YOU OR YOUR DEPARTMENT will be billed for the total cost associated with your registration (including shipping of the invoice), regardless of your affiliation.
- 3) All communication regarding changes to the location, cancellation of the course, or time and date adjustments will be made via email. In the event you arrive late, you may not be permitted to the course. This will count as a failure to show for the course and could result in an invoice being sent to you or your department.
- 4) All courses are limited to 15 participants due to COVID-19 regulations. All class participants are required to file ALL county, state, and federal regulations.
