

## **EOC Operations for All Hazards Course to be taught in Kearneysville by TEEX**

The Texas Engineering and Extension (TEEX) will teach its Management-345 Course, EOC Operations for All Hazards on October 15-17 at 128 Industrial Blvd., Kearneysville, WV 25430. This building is the Jefferson County Maintenance Department's Training Room. The EOC Training Course offers the participant insight into and practical experience with emergency management and decision-making skills necessary to effectively manage the overall response to a large scale WMD/Terrorism incident or an All-Hazard event utilizing the Multi-Agency Coordination System (MACS). This course will develop and reinforce emergency management, situational awareness, planning, information management, resource management and decision making skills for course participants. The course adapts existing emergency management (NIMS/ICS) proceedures to the unique requirements of EOC operations. Topics to include: Multi-Agency Coordination Systems (MACS) overview; MACS entities; Interrelationships; Roles and Functions of the EOC; Functional Areas; Organizational Models; Roles; Processes; Direction and Control; Information Management; Operations; Planning and Coordination; Resource Management; and Public Information Audience. This course is designed for supervisory and management personnel from all emergency response disciplines that have duties in the EOC. Participants should come from "Upper and Middle Management", i.e. Emergency Managers; First Line Supervisors; and administrators who will function as emergency coordinators/directors or emergency operations center (EOC) staff members. This course is not intended for basic firefighters, police patrol officers or EMTs. To enroll, go to http://www.onlinelearning.wv.gov/dmapscm6 and register online. The course is open to Emergency Management Agencies from throughout West Virginia.

# West Virginia Homeland Security Region 3 Annual TEPW (Training Exercise Planning Workshop) November at Hampshire County EOC, Romney

The creation of effective capabilities-based exercise programs begins with a multi-year training and exercise plan (TEP), which establishes overall exercise program priorities and outlines a multi-year schedule of training and exercise activities designed to address those priorities and validate core capabilities. The Training and Exercise Planning Workshop (TEPW) provides a collaborative workshop environment for Whole Community stakeholders to engage in the creation of the TEP. The TEPW also serves as a forum to coordinate training and exercise activities across organizations in order to maximize the use of resources and prevent duplication of effort. The first task of the TEPW participants is to identify factors for consideration in developing exercise program priorities. The following factors are considered: Threats and hazards, areas for improvement/capability assessments, external sources and requirements, accreditation standards, regulations, or legislative requirements. The group then links the factors to Core Capabilities. This process helps identify the areas most in need of attention. They then establish exercise program priorities that guide the overall exercise program. Finally a multi-year schedule is developed that outlines the exercises and associated training events that will address the exercise program priorities. During this phase, participants will focus on identification of potential exercises for inclusion in the multi-year schedule, identify training opportunities to support specific exercises, address areas for improvement or capability gaps or meet training requirements, and update the exercise schedule. TEPs should reflect a progressive planning approach that improves core capabilities through a series of exercises that involves an increasing level of complexity over time.

# **Emergency Management Assistance Company for City** and County Officials Webinar on October 17



The National Emergency Management Association, with cooperation of the National League of Cities and the International City/County Management Association, will present a webinar on the Emergency Management Assistance Compact, also known as EMAC. The intended audience members are city and county officials. The speakers will discuss what EMAC is, what local officials need to know, the importance of their relationship to the state Emergency Management Agency, and how resources are adjudicated, as well as their potential as a resource provider to other states in a disaster. The main presenter will be Joyce Flinn, current EMAC Executive Task Force Chair and Readiness/Response Bureau Chief at the Iowa Homeland Security and Emergency Management Division.

After the webinar a presentation package will be available for state EMAC Coordinators and other EMA officials to use when presenting the information to local officials as a follow-up to the national webinar. The presentation package gives the states an opportunity to discuss state policies on local and private deployments, local EMA relationships, contact information, etc.



#### Steering Committee, John Sherwood, Chair

The Steering Committee works with the JCHSEM Director to guide the activities of JCHSEM. A fourteen-member Steering Committee is made up of public and private representation. JCHSEM is a Department within the Jefferson County Commission, who has overall responsibility for the department and its employees. The Jefferson County Commission appoints all members to the steering committee. This committee meets on the 4<sup>th</sup> Tuesday of February. March, May, June, August, September and holds a Nov/Dec meeting at 9:00 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced. The Quarterly Partnership meetings held in January, April, July, and October also serve as the Steering Committee meetings for those months.

#### Public Awareness, Education and Training Committee, Kelly Parsons, Chair

Any interested person can serve on this committee. The Public Awareness, Education and Training Committee is responsible to communicate the organization's activities to the public and to build support for JCHSEM's programs. They work with the Director and other staff to keep the entire community focused on the objectives of JCHSEM, the opportunities for additional involvement and support by updating citizens and businesses about what the partners are doing and how the community will and is benefiting from these efforts. Additionally, they are responsible to assist the program manager is setting up speaking engagements and public awareness events. #### Risk Assessment and Mitigation Planning Committee, Jeff Jefferies, Chair

Any interested person may serve on this committee. The Risk Assessment/Mitigation Planning Committee will examine the community's risks and vulnerability to all hazards and assess the community's vulnerability to those risks. Additionally, they will look at specific buildings, infrastructure, etc. to determine which are most susceptible to risks. A Risk Assessment and Mitigation Plan was completed and adopted by the Jefferson County Commission, all Jefferson County municipalities, WVHSEM, and Federal Emergency Management Agency in July, 2003. The plan was updated in 2008. The 2013 Plan was approved by WVDHSEM and FEMA in June, 2013. This committee meets on an "as needed basis". #### Counter Terrorism Committee, Barbara Miller, Director, Chair

Membership to this sub-committee of the Risk Assessment and Mitigation Planning Committee is limited to members of law enforcement, emergency management, homeland security, emergency communications, Red Cross, schools, health care, fire companies, ambulance authority/EMS, and government, due to sensitive homeland security issues. The committee works on issues of planning and training for counter terrorism or human-caused disasters.
