SkyWarn Stormspotter Flood Program to be held in Jefferson County on March 13

The National Weather Service, Sterling Office, will hold a FLOOD Skywarn Stormspotter Class at Independent Fire Company on March 13, 2012 at 1900 hours (7:00 p.m.).

The Baltimore-Washington Forecast Office has been recruiting and training spotters into its expanded network since 1990. They currently have about 2000 active volunteers who cover 44 counties plus Baltimore City and the District of Columbia. Our network stretches west from the Chesapeake Bay across the eastern panhandle of West Virginia and south from the Mason-Dixon line through Fredericksburg, Charlottesville and Staunton in Virginia.

Volunteers are people who either have a strong interest in weather or are public service oriented such as amateur radio operators, REACT members, or emergency response personnel. Spotters are all ages beginning as young as 14 and range well into retirement age. They have farmers, pilots, engineers, housewives, lawyers, television cameramen, teachers, students, firemen, and more. Our volunteers are truly diverse but with a common interest in weather and a strong desire to help their community.

When hazardous weather occurs such as severe thunderstorms, floods, tornadoes, snow and ice storms, our volunteers report what is happening at their location. They are asked to report whenever certain criteria are met such as when one inch of rain has fallen, four inches of snow is on the ground, a thunderstorm is producing hail, or trees have been blown down. Reports arrive at our office via the telephone, fax, internet, and amateur radio. The reports are combined with radar and satellite data to determine what the storms will do next. Spotters provide the "ground-truth" to our forecasters. Radar may tell us that heavy snow is falling, but it can not tell us how much snow is on the ground or if rain is mixing with the snow. Spotters do. The reports are used by forecasters to send out public statements, warnings and advisories, and short-term forecasts. These products reach the public through the internet, NOAA Weather Radio, the media and other commercial services. Skywarn® reports also go into Storm Data, which is an official publication that documents severe weather across the country. Storm Data can be used to create a severe weather climatology (or history) of a local county or city. Storm Data is published (electronic and hard copy versions) by the National Climatic Data Center.

Two-thirds of volunteers are licensed amateur radio operators. Amateur radio plays a big role in the SKYWARN® program. During severe weather, amateur radio volunteers man a radio station at the NWS office. They talk to spotters in the particular area that a storm is hitting and request information needed by the forecasters such as hail size or rainfall accumulation. Large storms such as hurricanes can knock out phone service. Skywarn® Amateur radio volunteers help us when there are communications outages so that we can continue to receive weather reports and feed warnings and other critical information out to communities.

Jefferson County is a StormReady Community. As such, we partner with the National Weather Service office in Sterling to increase preparedness for natural hazard events. Part of our partnership includes hosting the SkyWarn Stormspotter Classes. We have been hosting these classes with the NWS for many years.





Jefferson County Homeland Security and Emergency Management-Committees

Steering Committee, John Sherwood, Chair

The Steering Committee works with the JCHSEM Director to guide the activities of JCHSEM. A fourteen-member Steering Committee is made up of public and private representation. JCHSEM is a Department within the Jefferson County Commission, who has overall responsibility for the department and its employees. The Jefferson County Commission appoints all members to the steering committee. This committee meets on the 4th Tuesday of February. March, May, June, August, September and holds a Nov/Dec meeting at 9:00 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced. The Quarterly Partnership meetings held in January, April, July, and October also serve as the Steering Committee meetings for those months.

Animals in Disaster Committee, Kelly Parsons, Chair

Any interested person can serve on this committee. The Animals in Disaster Committee is responsible for developing and updating the Animals in Disaster Plan and to work with the JCHSEM to make recommendations regarding the Animals Annex of the Emergency Operations Plan. They will also identify potential resources for animals before, during and after a disaster. The committee meets on the 3rd Monday of the months of January, April, July, October at 9:30 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.

Emergency Planning for People with Special Needs Committee-Amy Jones, Chair

Any interested person can serve on this committee. The Emergency Planning for People with Special Needs Committee is responsible for training and planning for issues of people who have mobility problems, people who have sight or hearing problems, people who speak a language other than English as their first language, the elderly and the very young, people who use oxygen or other medical devices and anyone who may need special assistance during times of disasters and/or evacuations. This committee will work with the JCHSEM to update the portion of the Emergency Operations Plan that deals with these special needs. This committee meets on the 3rd Monday of the months of March, June, September, and December at 9:30 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced. This room IS handicapped accessible.

Public Awareness, Education and Training Committee, Katherine Dunbar, Chair

Any interested person can serve on this committee. The Public Awareness, Education and Training Committee is responsible to communicate the organization's activities to the public and to build support for JCHSEM's programs. They work with the Director and other staff to keep the entire community focused on the objectives of JCHSEM, the opportunities for additional involvement and support by updating citizens and businesses about what the partners are doing and how the community will and is benefiting from these efforts. Additionally, they are responsible to assist the program manager is setting up speaking engagements and public awareness events. This committee meets on the 2nd Wednesday of each month except December at 8:30 a.m. in the EOC at 28 Industrial Blvd., Kearneysville unless otherwise announced.

Partnership and Volunteer Development Committee, Holly Morgan-Frye, Chair
