# April Thunderstorms, Flooding in Jefferson County

April, 2011 could well be classified as the rain storm that would not stop. Heavy rains saturated the ground in early April, followed by strong thunderstorms in mid-

A local resident is seen shoveling mud and rock debris from in front of his property on

River Road Sunday morning. He said he knew it affected the whole mountain and expected it might be awhile before the DOH could get to his road, so he was "trying to help them out." This sink hole opened up on private property near the junction of Rt. 230

and Nans-

field Drive. Sink holes are common in Jefferson County after heavy rains, due to the Karst topography in our region. Below is a picture of a Swift Water River Rescue that was needed when the driver of this truck tried to drive through standing water and was unable to do so. Luckily no one was hurt in this incident. However, most flood drown-

# OPERATION TROUBLED WATERS I & II COUNTY-WIDE EXERCISES

The Jefferson County Local Emergency Planning Committee sponsored two county-wide exercises during the month of April. The first was a TTX (Tabletop Exercise) that was held April 8th at the Jefferson County Sheriff's Office in Kearnesyville; the second was s FE (Functional Exercise) that was held in 4 venues around the county on April 22nd. These were: The Incident Command Post set up at C.W. Shipley Elementary School; a POD set up at the Jefferson County Health Department; the Jefferson County Emergency Operations Center in its building; and a Simulation Cell that was set up in the Jefferson County Sheriff's Department. The exercises brought participation from: Jefferson County LEPC; Jefferson County Homeland Security and Emergency Management; Jefferson County Emergency Communications; Jefferson County Sheriff's Department; Shepherdstown Police Department; Harpers Ferry Police Department; WV State Police; Friendship Fire Company; Citizens Fire Company; Blue Ridge Mountain Fire Company; Shepherdstown Fire Company; Independent Fire Company Jefferson County Emergency Services Agency; Jefferson County Department of Health; Eastern Panhandle Chapter, American Red Cross; Jefferson County Commission; Jefferson County G.I.S. Department; Jefferson County Maintenance Department; Town of Harpers Ferry; Corporation of Charles Town; Charles Town Utilities; WV Department of Highways; Jefferson County Schools; Jefferson Memorial Hospital; West Virginia Department of Environmental Protection; the U.S. Environmental Protection Agency; U.S. Customs and Border Protection Advanced Training Center at Harpers Ferry; Harpers Ferry National Historic Park; Jefferson County R.A.C.E.S.; Jefferson County C.E.R.T.; WV Region III Homeland Security Coordinator; and WV Division of Homeland Security and Emergency Management. Additionally, members from the media were invited to participate. Local media represented included: The Spirit of Jefferson; The Journal; and Hagerstown's WHAG-TV. Suzanne Griffin, a subject matter expert in media, assisted with public information under Jennifer Maggio, Jefferson County HSEM's public information officer. They, along with PIOs from the Red Cross and the Health Department formed a JIC for the first time

Three scenarios were involved in the functional exercise. These included flooding on the Shenandoah River that exceeded 30 feet; a chlorine gas leak at the Harpers Ferry water plant; and rising floodwaters derailed a train carrying several tanks full of hydrochloric acid.

"I was very happy with the turn out of people and agencies for both exercises," said Barbara Miller, Jefferson County's Emergency Manager. "No one knew the scenario ahead of time other than the contractors who developed the exercise, so we reacted to the injects as we have been trained to do and as we would do in a real incident. We had a good mix of people who had never participated in something like this in the past, working alongside seasoned participants. Exercises are a great place to learn, and to try new things before a real incident happens. This exercise

"It's simulated, but it's as close to real life as we can get it," said Doug Britvec, a project manager for J.H. Consulting and the director of the Friday night exercises. "It lets responders have an opportunity to see how they would respond, areas that need improvement, as well as areas they did well in," he said. Dave Withers of Friendship Fire Company said that he thought the exercise had been a success. "I think things went very well," he said. "I think it highlighted the fact that there's a lot of readiness in the county, that the EOC and the incident commanders and so forth are really good. We found a couple of things that need tweaking. Those will be tweaked and we'll be ready if it really happens."

# EPOCC Begins Animals in Disaster Regional EOP Annex

Jefferson Animals in Disaster Committee Helping

West Virginia's Homeland Security Region 3 (The Counties of Jefferson, Berkeley, Morgan, Hampshire, Hardy, Mineral and Grant) were recently awarded a Homeland Security grant to develop a regional annex for their respective Emergency Operations Plan. After reviewing responses to an RFP, J.H. Consulting, LLC was the low bidder and the group recommended hiring them to develop the annex. Work on the project has begun and is expected to continue through August, with a final document due by September. Each of the seven county emergency managers will serve as the point person within their respective counties and anyone interested in having input into the project should contact their county EM. In Jefferson County, JCHSEM's Animals in Disaster Committee will serve to review documents, do any needed research, and to assist with updating a list of animal resources.

# Statement by Secretary of Homeland Security Janet Napolitano on the Death of Osama Bin Laden




The death of Osama bin Laden is an important success not only for the United States, but the entire world. Our efforts to combat terrorism, however, do not fixate on one individual, and we remain completely focused on protecting our nation against violent extremism of all kinds.

We remain at a heightened state of vigilance, but the Department of Homeland Security does not intend to issue an NTAS alert at this time. I have been clear since announcing NTAS in January that we will only issue alerts when we have specific or credible information to convey

to the American public. However, our security posture, which always includes a number of measures both seen and unseen, will continue to respond appropriately to protect the American people from an evolving threat picture both in the coming days and beyond.

I commend the President and offer my gratitude to the men and women who defend and protect our nation at home and abroad, whether they wear a military or law enforcement uniform or serve as one of thousands of unsung heroes in the intelligence and homeland security community. It is true that we are stronger and safer than we were on 9/11 – not only because Osama bin Laden is dead, but because of the unflagging dedication and hard work of so many people throughout the world committed to freedom and security.

The course is designed to provide participants with knowledge and skills needed to design and implement an evacuation and re-entry plan for their jurisdictions. It uses a community's vulnerability analysis and evacuation plan. It also addresses behavior and recommends methods to make evacuation and re-entry more efficient. This course does not address the decision to evacuate or re-enter.

Selection Criteria: The persons responsible for planning, implementing, and carrying out evacuations within a jurisdiction should attend this course as a team. This course includes, but is not limited to, local and State government emergency program managers, emergency planners, and response personnel. G110, Emergency Management Operations Course (EMOC) for Local Governments 24 Hours

Instructors: Larry Allen/Jeff Harvey

The EMOC is an exercise-based program with planning sessions that begin weeks prior to the actual course, and it includes classroom sessions and exercises. The purpose of the EMOC is to improve operational capabilities as they relate to managing emergencies in the local community. The course places emphasis on the Emergency Operations Center as the focal point for managing a simulated emergency. Selection Criteria: Elected and appointed city and county officials. These include mayor, city manager, city council, county commissioner, county manager, and other key positions, such as emergency management director and public information officer. Also included as eligible participants, are upper and midmanagement personnel, including supervisory, operational, and communications staff from the fire service, law enforcement, public works, and emergency medical services. Volunteer groups should also participate.

### Steering Committee, John Sherwood, Chair

The Steering Committee works with the JCHSEM Director to guide the activities of JCHSEM. A fourteen-member Steering Committee is made up of public and private representation. JCHSEM is a Department within the Jefferson County Commission, who has overall responsibility for the department and its employees. The Jefferson County Commission appoints all members to the steering committee. This committee meets on the 4<sup>th</sup> Tuesday of each month at 9:00 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.

### Animals in Disaster Committee, Kelly Parsons, Chair

Any interested person can serve on this committee. The Animals in Disaster Committee is responsible for developing and updating the Animals in Disaster Plan and to work with the JCHSEM to make recommendations regarding the Animals Annex of the Emergency Operations Plan. They will also identify potential resources for animals before, during and after a disaster. The committee meets on the 3<sup>rd</sup> Monday of the months of January, April, July, October at 9:30 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.

### Emergency Planning for People with Special Needs Committee-Chair - Pamela Holstein-Wallace, Chair

Any interested person can serve on this committee. The Emergency Planning for People with Special Needs Committee is responsible for training and planning for issues of people who have mobility problems, people who have sight or hearing problems, people who speak a language other than English as their first language, the elderly and the very young, people who use oxygen or other medical devices and anyone who may need special assistance during times of disasters and/or evacuations. This committee will work with the JCOHSEM to update the portion of the Emergency Operations Plan that deals with these special needs. This committee meets on the 3<sup>rd</sup> Monday of the months of March, June, September, and December at 9:30 a.m. in the JCHSEM EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced. This room IS handicapped accessible.

### Public Awareness, Education and Training Committee, Katherine Dunbar, Chair

Any interested person can serve on this committee. The Public Awareness, Education and Training Committee is responsible to communicate the organization's activities to the public and to build support for JCHSEM's programs. They work with the Director and other staff to keep the entire community focused on the objectives of JCHSEM, the opportunities for additional involvement and support by updating citizens and businesses about what the partners are doing and how the community will and is benefiting from these efforts. Additionally, they are responsible to assist the program manager is setting up speaking engagements and public awareness events. This committee meets on the 2<sup>nd</sup> Wednesday of each month except December at 8:30 a.m. in the EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.

### Partnership and Volunteer Development Committee, Holly Morgan-Frye, Chair

Any interested person can serve on this committee. The Partnership Development committee assists the staff in identification and recruitment of potential partners and what they have to offer in community preparedness. This committee will be responsible for activities to promote partnership or membership development and recruitment of volunteers. This committee meets quarterly in the EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced. at 9:30 a.m. on the last Monday of January, April, July and October.

### Risk Assessment and Mitigation Planning Committee, Mason Carter, Chair

Any interested person may serve on this committee. The Risk Assessment/Mitigation Planning Committee will examine the community's risks and vulnerability to all hazards and assess the community's vulnerability to those risks. Additionally, they will look at specific buildings, infrastructure, etc. to determine which are most susceptible to risks. A Risk Assessment and Mitigation Plan was completed and adopted by the Jefferson County Commission, all Jefferson County municipalities, WVOHSEM, and Federal Emergency Management Agency in July, 2003. The committee currently updated the original document. This committee meets on an "as needed basis". Please call the office at 728-3329 for exact dates and times.

### Counter Terrorism Committee, Barbara Miller, Director, Chair

Membership to this sub-committee of the Risk Assessment and Mitigation Planning Committee is limited to members of law enforcement, emergency management, homeland security, emergency communications, Red Cross, schools, health care, fire companies, ambulance authority/EMS, and government, due to sensitive homeland security issues. The committee works on issues of planning and training for counter terrorism or human-caused disasters. Meetings are held on the 2<sup>nd</sup> Tuesday of the month at the EOC at 28 Industrial Blvd., Kearneysville, unless otherwise announced.
