The County Commission of Jefferson County, sitting as a Board of Canvassers, met this 14th day of November, 2016 at 9:30 am for the purpose of canvassing ballots cast in the November 8, 2016 General Election.

Commissioner Manuel led Canvassers and staff in the Pledge of Allegiance.

The Board proceeded with the Canvass by reviewing each precinct one at a time, checking to make sure the counts were accurate. The Board also reviewed the provisional ballots from each precinct to determine if the ballot in question could or could not be accepted to be counted. By random drawing, Precinct 4A was counted by hand.

After all provisional and absentee ballots were reviewed, the Commission added 106 provisional ballots and 40 absentee ballots count.

The hand count conducted for Precinct 4A was determined to be acceptable and did not affect the preliminary results of the General Election. The Commission thanked the Elections Board and Ms. Painter for their hard work in successfully managing a smooth election.
