Project Summary

1. Brief description of the proposal

Jefferson County Parks and Recreation seeks to develop an infrastructure plan, designed for future growth and expansion of James Hite Park. At present James Hite Park, located in the Leetown area of Jefferson County, has no water, sewer, or electrical infrastructure. The development of an infrastructure plan will allow for planned growth within the means and necessity of Jefferson County residents, related to the recreational use of the park. It is the goal of the Jefferson County Parks and Recreation Commission to designate and maintain a focus on green infrastructure initiatives within this park space. This plan will consider the feasibility

and develop metrics for green infrastructure practices and installation, while supporting the already developed park master plan.

2. Purpose and key anticipated outcomes

Jefferson County Parks and Recreation Commission strives to advance recreation and park growth and offerings in a planful way to benefit the largest populations while practicing fiscal responsibility. The James Hite Park master plan was developed with input from the community and to serve the needs for a wide variety of sports and recreational options for residents and visitors to Jefferson County. The park has been heavily utilized by travel soccer teams for game play since the park was opened to the public in 2015. At present the park includes a versatile, open field layout that allows for soccer play while maintaining the health of the grass playing surface, a fishing pond, a 2-mile walking/jogging trail, three picnic pavilions, and an accessible playground. Future plans for the park include baseball/softball fields, additional football fields, tennis courts, skatepark and dog park, which could allow regional tournaments if infrastructure is in place. Porta-pots are placed and utilized as restrooms throughout the season. Lights, water, and electricity are not available in the park and cannot be made available without the necessary infrastructure to provide these services. This is the first necessary step in making these necessary infrastructures upgrades, which will drive additional recreational tourism, including the potential to host large regional youth sports tournaments which attract overnight visitors from other areas, securing the future of this park.

The youth soccer community in Jefferson County is robust, thriving, and growing. Travel youth soccer groups utilize green spaces across Jefferson County, including the fields at James Hite Park. An estimated 1000 (250 EPIC, 650 AYSO, 100 WVFL) Jefferson County residents travel in various seasons for competitive, recreational youth soccer gameplay. Tournaments and larger-scaled games require participants and their families to travel to nearby states (Maryland and Virginia), as there are no public tournament spaces in Jefferson County that have the infrastructure to support them. It is the desire of JCPRC to help reverse the flow of traffic over our bridges to bring thousands of sports participants into our state and keep our residents here. This kind of athletic/recreational tourism will support economic development in retail, hotel, restaurant, and fuel sectors while supporting healthy play and future development of our parks. Infrastructure development at James Hite Park is necessary to attain this goal.

3. Individuals or communties served

Jefferson County Parks & Recreation provides recreational and arts programming for the county. It serves the populations of Charles Town, Ranson, Bolivar, Harpers Ferry, Shepherdstown, and Shenandoah Junction. Programs, festivals, and seasonal events draw participants from Jefferson and Berkeley counties in West Virginia, as well as visitors from nearby Maryland, Pennsylvania, and Virginia. In 2020, out-of-county participation in programming accounted for approximately 10% of overall customer participation. It can be said with confidence, offerings in the parks in Jefferson County draw visitors to the area, including James Hite Park.

4. How the COVID-19 pandemic has necessitated this request

Efforts to navigate the COVID-19 pandemic response while keeping public health a priority made evident the importance of public outdoor spaces. While concert venues, theaters, and indoor gyms remained closed to the public, outdoor events moved forward, bringing the community together in a safe environment. Participation and interest in outdoor activities grew faster than previous years. While this is likely due to response to COVID-19, growth continues to remain higher than any other measured data, including grocery stores, workplaces, transit, and more. The value in outdoor activities has been noticed and celebrated in West Virginia and around the United States. If new opportunities for shared community experience in our parks become available, it is reasonable to expect this momentum and appreciation for outdoor spaces and outdoor recreational play to be maintained or grow.

Access to outdoor spaces is important for the mental, physical, and social health of our community and visitors. One of the number one things coming from the pandemic is that families have refocused on the

importance of parks in their community. "Parks are not just green spaces. They're public spaces for people. They're not just for physical health, but for mental."

Proposal Details

1. Please describe the problem or need which your project seeks to address

The Project will result in a plan for infrastructure development that will serve as the basis to estimate the cost and begin implementation of park utility improvements, namely water, sewer, and electric service. JCPRC has been very successful in obtaining public and private grants for the development of park and recreation infrastructure. The plan developed from this project will put JCPRC in a position to apply for grants, including those supporting development of green infrastructure, to further develop Hite Park to better serve the interests of Jefferson County citizens and businesses.

2. Please describe goals and expected outcomes of your proposal.

The project will provide a site plan and costs associated with green infrastructure development of James Hite Park. JCPRC will not receive grants, loans, or other sources of funding if development plans for infrastructure are not in place. JCPRC will seek additional sources for funding assistance to provide water, restrooms, and concessions to park visitors including necessary grants. In 2019, it was estimated sports tourism in the United States generates \$8.96 billion, with 25.65 million players and spectators participating. All our partners would benefit from this project.

This project focuses on infrastructure planning that will provide sustainability for future development, environmental impacts, and economic development. Jefferson County Parks and Recreation Commission provides parks for recreation and leisure activities as part of the overall amenities bringing growth and development to Jefferson County. An infrastructure plan will create a roadmap for future development as indicated on the James Hite Park master plan.

Its mission is to take a leadership role in harnessing resources for planning, developing, implementing, evaluating, and operating a county-wide system parks, recreation, conservation areas, and trail opportunities for people who live, work, and visit here.

2. Describe the history of your organization, tell us about your current programs and activities

The Jefferson County Parks and Recreation Commission (JCPRC), established in 1970, is a component unit of the Jefferson County Commission. It is run by an eleven-member volunteer board.

JCPRC, a 501c3 organization, operates or maintains nine county parks that encompass over 400 acres of park land and a variety of park facilities, including the Jefferson County Community Center, the AMP, picnic pavilions, concession stands, walking trails, playgrounds, tennis courts, athletic fields, and open space. In addition, JCPRC offers over 400 program opportunities each year to youth and adults in the county. As part of programming, JCPRC offers numerous special events each year. JCPRC generates approximately 51% our budget from revenue-based programming and facility rentals.

3. Please describe three significant accomplishments of your organization.

Purchase and development of 119-acre James Hite Park. The park provides much needed sports and recreation fields and facilities. The sports played on the fields keeps Jefferson County children's sports in Jefferson County.

AMP at Sam Michaels Park – 40 year project brought to fruition

Offer over 400 programs and activities that promote public health already in place. Additional programs will be added as parks grow.

Developed a 10-year Park Master Plan to ensure responsible, forward-thinking public parks. Received over \$1,500,000 in grant funding.

JCPRC will contribute \$25,000 to the development of a green infrastructure plan. Additional development grants are in the process of being applied for; including the addition of tennis/pickleball and basketball courts as well as a tot lot through the West Virginia Land and Water Conservation Fund. We anticipate the grant application in the amount of \$250,000.

Impact of the COVID-19 Pandemic

1. Please explain the impact of the COVID-19 pandemic and how it relates to your request.

Early in the COVID-19 pandemic WV provided a list of essential services and public outdoor space was prominent in the list with outdoor recreation identified as an essential activity, even during the periods of stay-at-home orders. According to NRPA, the park usage grew exponentially during the pandemic. The Jefferson County Park System also saw this increase and part of the adaptation to accommodate it was the provision of portable toilets. At Sam Michaels Park in particular usage levels were high due to the wide array of outdoor amenities. However, Sam Michaels Park is on a septic system which, while well maintained, cannot support the increase in park attendance required to improve the resiliency of this park to function as an essential service during this or any future pandemic.

Populations flooded public parks in response to mitigation of the COVID-19 pandemic. When theaters, gyms, restaurants, and school classrooms were closed, families and whole communities flocked to parks, trails, amphitheaters. Family and community events moved into outdoor spaces as burn-out from interior and virtual spaces took hold. A return to natural places and open air drove populations to new places. Jefferson County is home to the Harpers Ferry National Historical Park and the Appalachian Trail Conservancy which recorded this extreme tourism growth. JCPRC reopened The AMP at Sam Michaels Park to record numbers of concert goers and saw participation in camps and outdoor rentals flourish. Even as the pandemic response wanes, continued appreciation for the outdoor spaces in Jefferson County Parks remains. As the population continues to grow around are parks, growth of parks and park infrastructure is imperative to continue growth in to meet the new-found demands of recreational tourism in our community.

2. How will ARP funding, if awarded, aid in the recovery from the COVID-19 pandemic?

Populations flooded public parks in response to mitigation of the COVID-19 pandemic. COVID-19 responses redirected activities and focus to outdoors, which elevated the urgency to further develop and maintain park spaces in Jefferson County. James Hite Park continues to support outdoor sports and recreational play for Jefferson County children and adult residents and visitors to our community. Infrastructure planning is necessary for continued growth, highlighting the health and wellness of our populations in the Eastern Panhandle.
