Project Summary

1. Brief description of the proposal

Revenue replacement for unbilled vaccine administrative costs as well as lost revenue due to a focus on COVID vaccination at the expense of other billable clinical services.

Additional staff to perform community outreach to promote public health and the services of the Health Department.

In addition an upgrade to the HVAC system in the Health Department building. The current system routinely fails, undercools in summer, and underheats in winter. It also is unable to be controlled in individual zones in the building resulting in widely different temperatures in different locations.

2. Purpose and key anticipated outcomes

The purpose is to replace lost revenue and funds that occured during the COVID pandemic due to a shift in priorities as mandated by the State of West Virginia. Replacing funds lost to being forced into paying overtime to clinical workers for extended shifts. It is anticipated that replacing the lost funds and income will put the Jefferson County Health Department in a more secure financial situation.

Upgrading or replacing the HVAC system would result in a more comfortable environment for the staff and visitors of the Health Department.

3. Individuals or communties served

Jefferson County West Virginia and neighboring counties in WV, Maryland, and Virginia, including Loudoun County VA, Frederick Counties MD and VA, Berkeley County WV, and Washington County MD.

4. How the COVID-19 pandemic has necessitated this request

The COVID-19 pandemic has forced personnel reallocations toward COVID vaccinations and away from other clinical activities that generate more revenue. It also increased staff overtime hours putting a strain on the Health Department personnel budget. Staff overtime was a result of an increase in demand for nurses to provide COVID vaccinations as well as increased overtime due to staff losses among nurses and administrative staff.

The COVID-19 pandemic has also affected the reputation of the public health system generally and the Health Department specifically. The addition of community outreach staff would further improve the reutation of the Health Department as well as promote Health Department services.

Replacing the HVAC system would create a more comfortable environment in the waiting room for patients seeking COVID vaccines. The waiting room is often crowded during COVID vacccination days and can become hot in summer.

This is accomplished through clinics, educational material, enforcement, disease control, planning, immunization, technical assistance and inspections. Our medical services are available to all persons regardless of race, color, sex, religion, national origin or ability to pay.

2. Describe the history of your organization, tell us about your current programs and activities

The Jefferson County Health Department was estblished by Chapter 16 of the WV Code. "It is the policy of this state to promote the physical and mental health of all of its citizens and to prevent disease, injury, and disability whenever possible." We provide public health services, health education, environmental health promotion, environmental inspections and permitting. On the clinical side, generally, we offer family planning, immunization (pediatric and adult), and communicable disease monitoring services. On the environmental side we provide food establishment, well and septic, public services building, inspections and permitting. Threat preparedness and emargency preparedness.

3. Please describe three significant accomplishments of your organization.

The Jefferson County Health Department has accomplished: 1.) helping Jefferson County to become one of the most vaccinated county's in West Virginia, 2.) being the lead county agency for public health information, education, and guidance, 3.) the main provider for shcool and pediatric immunizations that were neglected during the COVID-19 pandemic, helping children to be prepared to go back to full in-person schooling.

West Virginia required that local health departments focus solely on COVID mitigation and vaccination; with little to no reimbursement for services rendered. This precluded the Health Department from providing more lucrative services and diminished revenue on the clinical side of the department.

It will allow the Health Department to maintain staffing levels as well as allowing for the hiring of an outreach employee. It will also help to restore lost funds due to the revenue decline in clinical services.
