

TERMS AND CONDITIONS OF AWARD FROM JEFFERSON COUNTY COMMISSION'S AMERICAN RESCUE PLAN GRANT PROGRAM

David Deamer hereby agrees to the following terms and conditions for receipt of an award from the Jefferson County Commission's American Rescue Plan Grant Program ("the award"). David Deamer agrees that the award is contingent upon David Deamer's compliance with the following terms and conditions.

OBLIGATIONS – David Deamer understands that the award is being funded by the Jefferson County Commission based upon the representations made by David Deamer in David Deamer's application for the award. David Deamer agrees that the information provided in David Deamer's application was and is true and accurate to the best of David Deamer's knowledge. David Deamer further agrees that the award will be used solely for the purpose or purposes identified in David Deamer's application and approved by the Jefferson County Commission. David Deamer further agrees to provide quarterly reports, with the first report due December 31, 2021, of expenditures for and progress made in furtherance of the award. If, for any reason, David Deamer is unable to use the award for the purpose or purposes identified in David Deamer's application, David Deamer agrees to immediately notify the Jefferson County Commission, in writing, and agrees to provide a detailed written statement of the reason for David Deamer's inability to use the award for the purpose or purposes identified in David Deamer's application.

ADDITIONAL OBLIGATIONS SPECIFIC TO YOUR AWARD:

EXPENDITURES – David Deamer agrees to provide the Jefferson County Commission with quarterly reports of expenditures of the funds awarded. David Deamer agrees to track all expenditures by providing the amount and purpose/use of each expenditure. David Deamer further agrees to maintain records (invoices, receipts, contracts, etc.) of all expenditures and to include copies of those records with each quarterly report.

RECOUPMENT – David Deamer understands that the Interim Final Rule issued by the United States Treasury Department provides for the recoupment of funds used in violation of the American Rescue Plan and its enacting regulations and guidelines. David Deamer agrees to refund the Jefferson County Commission for any and all recoupment of funds caused by David Deamer's failure to provide true and accurate information in David Deamer's application for funding. David Deamer further agrees to refund the Jefferson County Commission for any and all recoupment of funds caused by David Deamer's failure to use the award solely for the purpose or purposes identified in David Deamer's application and approved by the Jefferson County Commission.
