1. Brief description of the proposal

 Charles Town Horsemen's Benevolent Protective Association (CT HBPA) Funding Proposal #1 is to request \$65,000 for an economic impact study of the Thoroughbred racing and breeding industries. Request Adjusted from \$65k to \$50k on 8/11/22

2. Purpose and key anticipated outcomes

• The purpose is to identify the economic impact of the Thoroughbred Racehorse Industry on West Virginia state and local economies. The study will provide reliable data and analysis that will assist governmental and budgetary decision makers in making informed decisions that will affect the economic stability of the Thoroughbred and related industries. Our impact crosses business sectors including agribusiness and tourism.

3. Individuals or communities served

• Individuals and businesses that breed, sell, own and race Thoroughbred horses, residents and local governments of surrounding cities and municipalities, and other local Counties, and the State of WV. Taxes generated in our industry support farming and green space, real estate, hotels, restaurants, insurance, education and more.

4. How the COVID-19 pandemic has necessitated this request

 A lack of revenue to our administrative budget in 2020 has necessitated this request. We experienced a significant loss of revenue in 2020 Q2 and Q4. Additionally, those we intended to partner with for the cost of the study also experienced revenue loss.

• Our last report was a 2012 study. We need an updated study that provides relevant and timely analysis to position our industry post COVID-19.

• Quantifying the Thoroughbred industry's economic impact will demonstrate to legislative leaders and decision makers that investments in our industry will continue to generate positive return on investment and economic benefits to residents, businesses, farming, tourism, local and State government.

• West Virginia Thoroughbred Breeders (WVTBA) is a partner. Their administrative office is in the same building as the CT HBPA. We leverage our relationship because the success of Thoroughbred racing and breeding are so intertwined. The Mountaineer Park HBPA (MP HBPA), located in Hancock County, WV represents horsemen that race and train at the Chester, WV track. WV horsemen run at both tracks. Together we are stakeholders as the success of the WV Thoroughbred industry is shared by participants at both tracks.

6. Please describe your plan for sustainability of the project or initiative after the grant award has been exhausted.

• This grant will provide relevant data needed for several years. The last report done 10 years ago was relied on and highly utilized. The CT HBPA, WVTBA, and MP HBPA will be able to share in the additional cost of marketing, education and travel expenses needed to communicate the information to legislative leaders and decision makers.

We are Horsemen Helping Horsemen.

2. Describe the history of your organization, tell us about your current programs and activities

• The precursor to the CT HBPA was incorporated in 1988. The CT HBPA is a non-profit trade association that works to support the sport of thoroughbred racing. We do this by instituting programs that protect the general welfare of the racing industry, as well as the interests of the horsemen, their employees and families. This includes administering a retirement program, a medical trust and assistance fund for those with a demonstrated financial need. We also work to improve communication between the horsemen, the racetrack, the West Virginia Racing Commission, government entities, and the public. The current racetrack has been in operation since the early 1930's and is as much a fiber of the community as our courthouse, where the famous trial of John Brown occurred.

${\bf 3. \ Please \ describe \ three \ significant \ accomplishments \ of \ your \ organization.}$

• The horsemen at the track were deemed essential during the COVID shutdown. Though the casino video lottery terminals, table games, and live racing operations were closed, we were able to negotiate with Hollywood Casino at Charles Town Races (HCCTR) and rely on CT HBPA cash reserves to pay for HCCTR security and maintenance to keep training open for our horses to exercise. This was an expensive but necessary cost of doing business in order to protect the safety and welfare of our horses.

- During COVID, with the assistance of generous businesses and a national Thoroughbred charitable organization we secured nearly 30 tons of donated grain, feed supplements and forage that were distributed to trainers to assist in caring for their animals while there was no income due to live racing being shut down.
- We successfully appealed to the West Virginia Racing Commission to permit horsemen to take emergency disbursements from their accounts in the WV Racing Commission Retirement Plan for Backstretch Personnel. Over \$1.1 million was distributed to qualified horsemen through those emergency disbursements.
