# Jefferson County Homeland Security and Emergency Management Public Awareness Committee October 13, 2010 Minutes

Jefferson County Homeland Security and Emergency Management's Public Awareness Committee met at the Jefferson County EOC on October 13, 2010 at 9am. Present were: Terri Mehling, JCHSEM; Jennifer D. Maggio, JCHSEM, Mike Davis, CERT; Patricia Davis, CERT; Katherine Dunbar, Good Shepherd Care Givers and Debbi Palmer, Eastern Panhandle ARC.

Ms. Mehling opened the meeting. Ms. Palmer approved the minutes from the previous meeting.

#### **Old Business**

Ms. Mehling reported the Disaster Ready Kids 2010 program had a total of 282 children. We are now shifting to October for Fire Prevention Month.

Ms. Mehling reviewed activities that went on during National Preparedness Month. Activities included Family Disaster Preparedness Night, Lunch N Learn sessions and discounts on disaster preparedness items at Wal-Mart. Ms. Mehling announced Peggy Sclater is the winner of the Disaster Preparedness Photo Contest.

#### **New Business**

The Committee agreed to change the meeting time to Wednesday at 8:30 am.

Ms. Palmer reported on upcoming Red Cross classes. Health and Safety classes will be held every Saturday until the end of the year; CPR classes are rotating between Berkeley County and Jefferson County and DAT meeting November 17 at 6 pm. Ms. Palmer announced Red Cross has received 2 AmeriCorps Volunteers. Ms. Palmer also announced there are two cold weather shelters in Jefferson County. A men's shelter will be located at the Episcopal Church on Zion road from Jan 1-March.A women's shelter will be located at the St. James Church starting in November. Red Cross will supply cots.

Ms. Maggio reported the Fire Prevention Month Ready Program is currently being held throughout the month of October. There are currently 680 children involved and volunteers are needed. Ms. Davis asked Ms. Maggio to please let her know of some dates and she can see if she is available. Ms. Dunbar suggested calling the Retired Teachers Association for assistance in reading.

Ms. Mehling announced she will be attending CERT Train-the -Trainer and Program Manager Course at the Emergency Management Institute October 18-22.

Ms. Mehling announced the Quarterly Partnership Luncheon will be October 27 at the Bavarian Inn. Thom Kirk from the WV Intelligence Fusion Center will be speaking. You will have two meal options, Chicken Piccata or Veggie Lasagna and Black Forest Cake or Ice Cream. Meals will cost \$15.00 and you will need to RSVP by calling Jennifer Maggio at 304-724-8914.

Ms. Mehling announced there will be a People with Special Needs Exercise on November 4 from 9am-2pm at the Clarion Hotel. Ms. Mehling handed out an article based on the upcoming exercise and how to sign up.

Ms. Mehling reported the National Weather Service Winter Storm class on November 8 at 7pm has been moved from JCHSEM to the Shepherdstown Fire Department due to a large response. Ms. Mehling is working on a press release. Ms. Dunbar asked to be added to the list.

Ms. Mehling reported the recommended EMI Course for October is IS-230a—Fundamentals of Emergency Management. This class involves the basics of what is involved in dealing with emergencies.

#### **Member Sharing**

Ms. Mehling announced she is now accredited through the state as a Level 3 Emergency Manager.

Ms. Mehling announced there will be a Decon Training for Jefferson Memorial Hospital at US Customs and Border Patrol. Larry Neal and Jeff Jefferies staff as well as Berkeley County Health Department Staff will be attending. JCHSEM will be there to observe.

Ms. Mehling reported on an upcoming Mass Evacuation Exercise at the Veteran Affairs Medical Center in Martinsburg, WV. A train will derail behind the VA Center which will cause all of the patients to evacuate and relocate to another medical center.

Ms. Dunbar announced Good Shepherd Caregivers has moved into their new facility. She will notify the group when they have their open house.

Jefferson County Homeland Security and Emergency Management's Public Awareness Committee met at the Jefferson County EOC on January 12, 2011 at 8:30am. Ms. Mehling, JCHSEM Deputy Director, opened the meeting with approval of minutes. Mike Davis moved to approve the minutes of the October 13, 2010 meeting and Katherine Dunbar seconded the motion, all approved.

#### **Old Business**

Ms. Miller reported on her recent attendance to the WV Homeland Security Summit from November 16-18 at the Greenbrier Hotel. Ms. Miller shard her experience with the committee on the tour she was given in the bunker that was built in 1958. There were several breakout sessions during the summit that focused on 7 different investments that included COOP, critical infrastructure, credentialing, etc.

Ms. Miller reported JCHSEM attended TEEX EOC Operations Class, November 30-December 2 in Martinsburg. Ms. Miller reviewed the class curriculum and mentioned it was very interesting to see how all EOCs work throughout the region.

#### **New Business**

Red Cross was unavailable to comment on upcoming classes.

Ms. Mehling announced the Quarterly Partnership Luncheon will be held at noon on January 19 at Hollywood Casino at Charles Town Races. If you would like to attend, please contact her.

Ms. Miller reported the WV State Legislature recently passed a law that all Day Care facilities have to create a Disaster Plan. They must share those plans with their local Emergency Manager by December 31, 2010. This is now a requirement to renew day care center license. Ms. Miller plans on critiquing the plans and visiting the facilities to discuss possible changes.

Ms. Miller announced there will be an Emergency Operations Center Training, January 18 and an exercise on January 29. Ms. Miller recommends those who would like to work in an EOC and those who are already active within the EOC to attend.

Ms. Mehling reviewed the 2011 Public Awareness, Education and Training Strategy document with the committee. She is currently in the process of changing the list of EMI study courses. Ms. Miller reviewed the list of updated recommended courses. Once the Professional Development series is complete you will receive an additional certificate for completing the entire series. Ms. Davis asked Ms. Miller if there is a consolidated list online. Ms. Miller noted on FEMA's website you can search professional development series.
