Present were: Terri Mehling, JCHSEM; Jennifer Maggio, JCHSEM; Mike Davis, CERT Volunteer and Jennifer Kerr, 167th Airlift Wing Fire Department.

Ms. Mehling, Deputy Director, opened the meeting with approval of minutes. Mike Davis moved to approve the minutes of the May 18, 2011 meeting and Jennifer Kerr seconded the motion, all approved.

Old Business

Ms. Mehling reported on Ranson Day that took place May 21, 2011. She and Ms. Maggio split the day with volunteers. Preparedness packets were handed out to around 50 people and approximately 6 CERT forms were completed and returned.
