Jefferson County Homeland Security and Emergency Management's Public Awareness Committee met at Jefferson County Homeland Security & Emergency Management on June 08, 2011 at 8:30am. Present were: Terri Mehling, JCHSEM; Jennifer Maggio, JCHSEM; Mike Davis, CERT Volunteer and Jennifer Kerr, 167th Airlift Wing Fire Department.

Ms. Mehling, Deputy Director, opened the meeting with approval of minutes. Mike Davis moved to approve the minutes of the May 18, 2011 meeting and Jennifer Kerr seconded the motion, all approved.

Old Business

Ms. Mehling reported on Ranson Day that took place May 21, 2011. She and Ms. Maggio split the day with volunteers. Preparedness packets were handed out to around 50 people and approximately 6 CERT forms were completed and returned.

Ms. Mehling reported on Disaster Ready Kids Summer Program. She and Ms. Maggio will be reading to the summer camps for Jefferson County Parks and Recreation. Briggs Animal Adoption Center also requested pet preparedness classes for their summer camp.
