- 2. Meeting Called To Order @ 6:00 PM
- 3. Refusal to Certify Deven Tyler Morris
 - a. Mr. Cox announced that JCDSCSC refused to certify Mr. Morris based on information received:
 - i. Mr. Morris' letter of resignation dated March 30, 2021 addressed to Sheriff Harmon of Berkeley County.
 - ii. Memo from Sheriff Harmon to the Berkeley County Council regarding Resignation in lieu of Termination/Deven Morris.
 - iii. Charges brought against Mr. Morris as a result of an internal investigation were not dropped or removed.
 - iv. Normally at this time, Mr. Morris would have an opportunity to speak.
 - v. Mr. Cox read the email received at our general inbox from Mr. Morris on April 28, 2022 at 3:32 PM requesting to remove his name from the agenda.
 - vi. This public hearing was scheduled solely to address this matter. This was advertised and could not be cancelled.
 - vii. Mr. Cox called for a motion for JCDSCSC to reevaluate its position refusal to certify Mr. Morris. **No motion was made.**
 - b. **Public Comment -**Sheriff Hansen spoke as the Appointing Officer for JCSO spoke:
 - i. Based on Law Enforcement Professional Standards (LEPS), Mr. Morris' certification is not suspended or revoked, it is inactive. When you resign from an agency, they (LEPS) automatically put it on the inactive list. As long as you are hired by another agency and catch your in service up, you certification status is changed to active. LEPS has not taken any action against Mr. Morris. What Berkeley County did or didn't do has no bearing on Sheriff Hansen hiring Mr. Morris'. According to LEPS, he would have to appear in front of them (LEPS) for a meeting to determine if it was justified or if there was any problem, and he would be certified again. His certification is not revoked or suspended.

- g. Mr. Liston will draft a letter to Mr. Morris advising him of the outcome and Ms. Nelson will email a copy and mail the original letter to his home address.

MEMORANDUM FOR: Berkeley County Council

SUBJECT: Resignation In Lieu Of Termination/Deven Morris

- On 30 March 2021, Sheriff Nathan Harmon informed Deputy Deven Morris that the Sheriff intended to terminate Deputy Morris' employment as a deputy sheriff based upon an internal investigation.
- 2. On this date Deputy Morris indicated on the Statement of Charges and Recommendation of Action that he requested a hearing before a hearing review board. Afterwards Deputy Morris indicated that he would prefer to just resign.
- 3.. On 30 March 2021, Deputy Morris submitted his formal letter of resignation. The charges were not withdrawn and the resignation was accepted "In Lieu Of Termination".
- 4. As a result of this action, the hearing board was cancelled and Deputy Morris' date of resignation was effective 30 March 21.
