# Scholarship Application

## INSTRUCTIONS

It is the policy of the Jefferson County Parks and Recreation Commission to make program opportunities available to all interested people, regardless of income. We provide scholarships to those who might not otherwise be able to participate. Scholarships may be granted for a percentage discount of the class fees, depending on individual circumstances. All information will remain confidential.

### To be eligible for a scholarship:

- You **MUST** reside in Jefferson County, West Virginia and meet the household size/yearly income requirements.
- Supporting documents **MUST** be included with this application.
- Applications are accepted on a rolling basis. Applications must be submitted 2 weeks prior to the program start date to be considered. Scholarships will be valid for one fiscal year (July 1-June 30) following approval.
- Applicants meeting the eligibility guidelines are awarded up to \$165 per participant, per fiscal year, subject to funding.

**W2 or paystub MUST be included with this application for all income earners in the household over the age of 21. Application will not be considered if documents are not included.**

### **Scholarship applications must be approved prior to registration.**

A scholarship application alone does not register the participant, nor does it reserve space in a program.

Registrations are processed in the order received. You will be notified once your application for scholarship has been reviewed.

- Applications must be submitted yearly during the application period.
- All previously awarded scholarships will expire on June 30.
- Applications will not be considered without supporting documentation (W2 or paystub)
