- 6. Amend the Capital Improvement Plan to include the purchase of 330 N. George St., Charles Town, WV.
- 7. Amend the Impact Fee Study to include the purchase of 330 N. George St., Charles Town, WV.
- 8. Authorize the Commission President to sign the purchase and sale agreement dated March 20, 2025, and all other documents necessary to bring the purchase and sale agreement to closing.
