- 2. <u>Contingency Date</u>. Notwithstanding anything in the Original Agreement to the contrary, the Contingency Date is hereby extended from March 7, 2025 to May 6, 2025.
- 3. <u>Full Force and Effect</u>. Except as expressly amended by this First Amendment, the Original Agreement will remain in full force and effect in accordance with its terms, provisions and conditions.
- 4. <u>Counterparts; Electronic Transmission</u>. This First Amendment may be executed in any number of counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument. To facilitate execution of this First Amendment, the parties may execute and deliver by facsimile or electronically mailed (e-mailed) counterparts of the signature pages and electronic signatures.
