The County Commission of Jefferson County, sitting as a Board of Canvassers, met this 13th day of November, 2006 at 10:00 a.m. for the purpose of canvassing ballots cast in the November 7th, 2006 General Election.

Jennifer Maghan, County Clerk, was present for the Canvass. Matthew Barney and Nikki Painter, from the County Clerk's office, were also present and assisted with the Canvass.

The Board randomly selected Precincts 6 & 17 to be hand counted. The Board designated a team of 4 to perform the hand counts. The hand count team consisted of Frankie Remaley, Harriet Monroe Miller, Alicia White and Wendy Kirby.

The Board proceeded with the Canvass by reviewing each precinct one at a time, checking to make sure the counts were accurate and to review the provisional ballots from the polls and the ballots that were marked provisional at the Courthouse on election night due to missing poll clerk signatures. The Commission reviewed each provisional ballot to determine if the ballot could or could not be accepted to be counted.
